In the event of her claim being found genuine, the Board agreed to expunge the adverse remarks that appeared in the ACR of Mrs Kanika Sharma during the year 2008-09, with the rider that Mrs Kanika Sharma may be issued an advisory enjoining her not to bypass her Head of Department at any time in future.

He will be provided with a separate chamber and the present chamber will continue to be occupied by the FIA.

Centre for Physically Challenged, NITTTR, Chandigarh in collaboration with Northern Chapter of Confederation of Indian Industry (CII), organized an **Ability Fair 2010** for differently abled persons in a phased manner. Five such job fairs were organized on 24 April, 28 April, 5 May, 25 May, 2010 and 6th July, 2010. Three well renowned companies namely Tech Mohindra Ltd., IBM Ltd. and Tata Business Solutions Ltd. visited the institute for recruitment of differently abled persons. The three companies recruited 43 persons for placement in their call centres.

ITEM NO.B.18.2.2 TECHNOLOGY PARK OF EMERGING TECHNOLOGIES FOR RURAL DEVELOPMENT – IIT DELHI SPONSORED PROJECT

This project is sponsored by IIT, Delhi. IIT, Delhi has released Rs.6.30 lakh as the first instalment out of a total grant of Rs.15.75 lakh. The project term is two and half years commencing from June, 2010. A Bio Gas Plant has already been installed on the Institute Campus under the

project. The main purpose of installing the Bio Gas plant is to utilize kitchen waste (Vegetable Waste) and use bio gas as cooking fuel, in the institute's canteen. A 4 cubic metre capacity Deen Bandhu Model of Bio Gas Plant was constructed with the help of KVIC Chandigarh and was inaugurated on the eve of the World Environment Day on 4th June, 2010. IIT Delhi project is a part of a bigger project on "Bio Energy: Technology Business Solution for UK and India."

ITEM NO.B.18.2.3 MeLT VAN - A PRIZED ACQUISITION GIFTED BY IIT, ROORKEE

The Mobile e-Learning Terminal (MeLT) project of IIT Roorkee sponsored by MHRD, Govt. of India under "National Mission on Education using ICT" is an innovative approach to reach the remote regions of the country to offer education through blended learning. Prof. H.K. Verma, Deputy Director of IIT Roorkee and PI of the project, after interacting with NITTTR Chandigarh, more specifically with the ETV Centre of the institute, realized the potential of the centre and handed over a MeLT Van to ETV Centre to carry out activities to meet the national objectives. The ETV Centre conducted three programmes on April 30, 2010, May 01, May 06 and 07, 2010 at various place at Chandigarh and Derabassi which were highly appreciated by the organisations. The Stenographers Grade-III in the pre-revised pay scale of Rs 4000-6000 shall be designated as Stenographer Grade-II as per letter under reference. Accordingly, the Model Recruitment Rules for the post of Stenographer Grade-II in the pre-revised scale of Rs 4000-6000 and revised pay band PB-1 Rs 5200-20200 with Grade Pay Rs 2400/- are enclosed as Annexure-VIII at page No.31 to 33 in the light of 6th Central Pay Commission recommendations.

This institute has five posts of Stenographer Grade-III which may be redesignated as Stenographer Grade-II in the light of above referred letter dated 10-03-2010.

The last date for receipt of applications was 14.10.2010. The screening of the applications was conducted by the respective departments by inviting two experts from outside. The Screening Committee recommended seven candidates for each post, the details of which are as under:-

A few internal candidates working in this institute had also applied for the post(s) of Assistant Professor(s). As per the criteria laid down by the Screening Committee(s), the number of candidates to be called for interview for each post is only seven. That is why, perhaps, the internal candidates could not qualify for being called for interview, although they fulfilled the basic qualifications laid down for these posts. The internal candidates are requesting the administration to consider their names for interview and the latter, having no power to relax norms, is bring it before the BoG to take a final call on this.

ITEM NO.B.18.4.7 PROMOTION OF DR. HEMANT SOOD FOR THE POST OF PROFESSOR UNDER CAREER ADVANCEMENT SCHEME

Vide UO No.15 dated 31.03.2010 the Chairman, Board of Governors, approved the selection committee nominating Dr. Pawan Kapoor, Director, CSIO, Chandigarh, to chair the Selection Committee to consider the promotion case under CAS of Dr. Hemant Sood, Associate Professor of Civil Engineering Department, for the position of Professor Civil Engineering.

The selection committee met on 13.05.2010 at NITTR Chandigarh to consider the case of Dr. Sood under CAS as per AICTE guidelines. The Selection committee recommended for promotion to next higher grade of Professor.

However, the case of promotion was withheld as two complaints were received by the office of the Hon'ble Chairman, stating that 'Dr.Sood is not having Ph.D. in the relevant discipline.' The Director had personal meeting with the Chairman, whereby the Chairman advised the Director to get the issue clarified by the AICTE before the UO note on Dr.Sood's promotion is formally sent to him. The Director of the institute sent several communications to AICTE on the subject and despite constant persuasion, no written communication has so been received from AICTE.

Very recently, in the website of the AICTE under the head 'FAQ (Frequently asked questions)' the mater has been amply clarified by AICTE. The full text of the same is attached as **Annexure** - **C**. Accordingly, a UO Note No.55 dated 25.10.2010 was sent to the office of Chairman, Board of Governors, to accord approval to the promotion of Dr.Hemant Sood from the post of Associate Professor to Professor under CAS.

However, the Chairman directed that the matter be placed before the Board of Governors.

Subject: Issue of Experience Certificate to Shri Ajay Mehra, Lecturer, Electronics & Communiction Engineereing by Shri KL Singla, Senior Administrative Officer – irregularity regarding

Shri Ajay Mehra had been working as Lecturer in Electronics & Communication Engineering department at this institute during the period from 13.2.86 to 12.2.88. His services were terminated on 12.2.1988(AN). An experience certificate for this period was issued to Shri Ajay Mehra by Professor PD Kulkarni, the then Principal of the institute vide letter No.Admn.E.1/PF/-AM/17528 dated 30.11.1988, which correctly stated the fact of termination of services of Shri Mehra. Later on, in December, 1995, Shri Ajay Mehra, through his father, Major Jagdish Chand Mehra(Retd), again requested for issuance of another experience certificate for the same period of his service. The second experience certificate was issued to him by the Senior Administrative Officer vide letter No.Admn/E-1/PF-AM/23191 dated 2.1.1996 under his own signature. The approval of the then Principal, Dr.MM Malhotra, for issue of such certificate was not obtained. The experience certificate was issued by the Sr. Admn. Officer at his own level without indicating the fact that the services of Mr Mehra were terminated, as was indicated earlier in the experience certificate issued on 30.11.88. Thus there were two gross anomalies in this second certificate issued by Shri KL Singla, then Senior Administrative Officer: (i) issuance of a second certificate was superfluous and uncalled for(ii) the certificate, presumably deliberately, did not make the mention of termination of services of Shri Mehra and was issued without the permission of the then Principal, Dr. Malhotra.

On being orally pointed out these gross anomalies by an ex-employee, the institute vide letter No.NITTTR/Admn/38946 dated 5.3.2010 requested Shri. Singla to clarify his position in this regard. Shri KL Singla vide his letter dated 17.3.2010 sent the reply, a photocopy of which is enclosed as Annexure-A.

In order to unearth the entire truth, Director constituted a committee consisting of of Dr. KM Rastogi, Dr. PK Tulsi and Dr. YK Anand, three very senior Professors of the institute. The Committee submitted its report on 10.5.2010, a copy of which is enclosed as Annexure-B.

The Committee in its findings indicated that it appeared to be a deliberate attempt on the part of Senior Administrative Officer to suppress the information regarding termination of services of Shri Ajay Mehra.

Findings of the Committee attract the provision of Conduct Rules, which is reproduced below:

Clause 2(ii) of Rule 3 of CCS Conduct Rule provides that no Government servant shall, in the performance of his official duties, or in the exercise of powers conferred on him, act otherwise than in his best judgement except when he is acting under the direction of his official superior'

The Chairman, Board of Governors may kindly consider according approval of framing charges against Shri KL Singla under the above said provision of Conduct Rules. Draft chargsheet is enclosed for signature of the Chairman, Board of Governors as Annexure-C.

Respectfully, in this regard, I am to state as under:

I joined the institute in July, 1994 and did not ever work under Principal (Prof) P_t, Kulkarni. This being a case about 15 years old, I am unable to remember its details.

However being a subordinate to the Principal/Director, I used to work under his supervision and control as per his orders/directions/instructions/guidance. As I was reporting directly to him, therefore, I also used to work in proper co-ordination and co-operation with him.

On my joining as Senior Administrative Officer, the then Principal had directed me dispose of maximum cases of administration at my own level and work with confidence and boldly on his behalf. He had also instructed that only those financial and administrative cases be put up to him where Principal's approval is necessarive required as per delegations of powers. He had also directed not to put up to him each and every case. He had full confidence in me and also provided full shelter and protection for the work done with good intention.

The issuance of experience certificate, was treated a routine matter. It was, therefore, disposed of at my level and since then none of the Principals/Directors ever objected to that. In my absence even the Section Officer of Establishment Section used to issue the experience certificate to the institute employees under his own signatures. Even that was not objected to by anyone.

I do not know even now who is Ajay Mehra. However the certificate was issued on the basis of official noting submitted to me by the Establishment Section, clearly indicating that Shri Ajay Mehra worked in the institute on probation, which means that his probation was never cleared. The certificate was issued in good faith.

Still in case of any mistake on my part, I apologise for the same.

RECOMMENDATIONS OF THE COMMITTEE

The committee appointed by the Director to examine the case of issuance of certificate to Shri Ajay Mehra, Ex Lecturer Electronics and Communication Engineering (1986-1988) by Shri KL Singla, Senior Administrative Officer met on 05.05.2010 at 3.30 in the office of Dr.K.M Rastogi.

The committee examined the relevant documents and was of the following views:

- (1) Senior Administrative Officer, after agreeing to the note put up by the dealing Assistant for issuing a photocopy of the experience certificate issued by the then Principal of the Institute vide letter No. Admn/E-1/PF-AM/17528 dated 30.11.1988(copy placed at page No.184-185 of personal file of Mr. Ajay Mehra) directed the office to issue a fresh experience certificate to the concerned person.
- (2) A fresh experience certificate was issued to Mr. Ajay Mehra (No.Admn/E-1/PF-AM/23191 dated 02.01.1996) without seeking approval of the competent authority. The argument put forth by Senior Administrative Officer in his reply letter dated 17.3.2010 has no basis or relevance. He has misused his powers as Senior Administrative Officer.
- (3) He did not take cognizance of the fact that the services of Mr. Ajay Mehra were terminated which was clearly indicated in the certificate earlier issued. This appears to be a deliberate attempt on the part of the Senior Administrative Officer to suppress the information regarding termination of services.

- On consideration of replies, I, Dr. KK Talwar, Chairman, Board of Governors, NITTTR, Chandigrh, level the following charges against Shri K.L.Singla, Senior Administrative Officer of this institute(now on deputation to NIPER):
 - (i) that he had issued experience certificate on 02.01.1996 under his signature to Shri Ajay Mehra, Ex, Lecturer, Electronics and Communication Engineering department of this institute without the approval of the competent authority.
 - (ii) That in the said certificate, he intentionally removed the fact that Shri Ajay Mehra was terminated by this institute.
 - (iii) That the concerned dealing Assistant and Section Officer in Establishment Section proposed to issue a photocopy(attested) of the said certificate earlier issued on 30.11.1988. Though the proposal was first okayed but finally a departure was made and a fresh experience certificate issued on 02.01.1996 under his own signatures without mentioning the fact of termination of Mr. Ajay Mehra's services and without the approval of the competent authority.

He is directed to submit replies to aforesaid charges within a period of 20 days failing which it would be presumed that he has nothing to say in his defence and action would be taken under service/conduct rules by the institute.

The accessing of AICTE web portal has some system requirements which are available under HELP menu. Kindly ensure that the configuration of your system with respect to hardware, software and bandwidth meet the system requirements.

The proformas for different types of applications like Increase in Intake, Supernumerary seats under PIO category, Tuition fee waiver scheme and additional seats etc. are not available on the portal?.

Only two application formats i.e. one for the New Institutions and another for the Existing Institution are available on the web portal.

Form for new Institutions can be used for,

- · Applying for new Institution / integrated campus
- · Applying for conversion from existing Institution to integrated campus.

Application from for Extension of approval shall be used by existing Institutions for,

- · Extension of approval for existing courses.
- · Applying for new programme /increase of intake / closure

Applying for schemes, such as, PIO / NRI / TFW

The application was submitted during the previous years and has already been processed to a certain stage like Letter of Intent, Expert Committee visit conducted etc. How will such pending applications be processed?

All such applications pertaining to previous years and pending at various stages of processing will have to be uploaded afresh as New Institution". However, the processing fee already paid during previous years may be adjusted while uploading the online application and only the differential processing fee needs to be paid.

Regarding infrastructure, which guidelines i.e. those in old approval process handbook or in new approval process handbook will be applicable?

Since all such pending applications are to be uploaded afresh, these will be governed by the new norms.

What intake will be allowed to the pending applications? As per the new approval process handbook or old approval process handbook.

Since all such applications are to be uploaded afresh and will be processed as per the new approval process handbook. These will be eligible for intake as per the new approval process handbook i.e. 300 for Engineering; 120 for Management, Pharmacy & HMCT and 80 for B. Arch.

Whether Government or Government-Aided institutions are exempted from paying the processing fees?

Only government institutions are exempted from paying the processing fee. However, the Government-aided institutions will have to pay the processing fees. Uploading of the required documents in a scanned form takes too much of time?

It takes a maximum of 48 hours to get the User_Id and password.
