ITEM NO.F.31.3.3 TO CONSIDER ENHANCEMENT OF HONORARIUM PAID TO EXPERTS INVITED FOR SHORT TERM COURSES ME /M.TECH

The Board of Governors in its 23rd meeting (vide item No.B.23.3.2) held on 13.03.2012 on the recommendation of Academic Council in its 13th meeting held on 28.2.2012 had approved the payment of honorarium to the experts invited for engaging session in a STC @ Rs. 1000/- per session subject to a maximum of Rs. 2000/- per person per day with a limit of Rs. 10,000/- per week per course and an amount of Rs. 500/- for engaging a session in ME/M.Tech Programmes. As the amount is very meagre in today's scenario, no expert from higher level institutions / Industry is ready to deliver lecture in STCs and ME / M.Tech programmes and conduct of evaluation of viva – voce examination of ME / M Tech thesis. NITs and many similar organisations are paying much higher honorarium to the experts invited for the above purpose (copy enclosed as **Annexure – IV** at page No.11).

Keeping in view the difficulties faced by the institute, the honorarium for the experts may kindly be enhanced as follows:

- (i) Engaging Session in STCs from Rs.1000/- to Rs.2000/- per session with a limit of Rs.16,000/- per week per course.
- (ii) Engaging Session in ME / M.Tech from Rs.500/- to Rs.1000/- per session.
- (iii) Conduct of evaluation and viva-voce examination of ME / M. Tech thesis from Rs.500/- to Rs.1000/-.
