This has reference to Appeal dated 09-03-2017 filed by you against the decision of NBA for granting Provisional Accreditation for 2 years to PG- Computer Science Engineering program of your Institute communicated vide NBA's letter of even number dated 04-02-2017.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 02-05-2017. The recommendation of the Appellate Committee was considered by the Competent Authority in NBA. Based on the decision taken, accreditation status of the program is given in the table below:

As such the Institution should nowhere along with its name including on its letter head etc., write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
