MOU between Dr. Fixit Institute of Structural Protection & Rehabilitation, Mumbai

and

National Institute of Technical Teachers' Training and Research, Chandigarh

and between Dr. Fixit 27th day of April 2022 This MOU is entered into on the Institute of Structural Protection & Rehabilitation, a not-for-profit Company registered under Section 25 of Indian Companies Act, 1956 and having its registered office at Regent Chambers, 7th Floor, Jamnalal Bajaj Marg, 208, Nariman Point, Mumbai - 400 021 represented by Director, for brevity further referred herein as DFI-SPR (which expression shall mean and include successors in office and or interest) as the first party, and National Institute of Technical Teachers' Training and Research, Chandigarh having its office at Sector 26. Chandigarh represented by the Director, for brevity further referred herein as NITTTR (which expression shall mean and include successors in office and or interest) as the second party.

Whereas both the parties have certain commonality of interest to enter into this MOU with a view to undertaking knowledge and skill up gradation as well as information dissemination programmes in the field of waterproofing, maintenance and repair of concrete structures.

Objectives:

This MoU is signed with the objectives of furthering industry-academic relationship for mutual benefit, building fruitful and mutual relations, and of proposing to offer programs of mutual interest as agreed by the parties. The Broad objectives are to

- Organise competency based training of faculty and staff of technical institutions.
- Organize skill development programs for the benefit of skilled and unskilled labor, contractors and Builders.
- Organize Technical seminars, workshops, conferences and training programmes in association with the Dr. Fixit Institute of Structural Protection & Rehabilitation, Mumbai to provide the civil engineering community with the latest developments in research and developments of construction industry.
- To arrange industrial visits, seminars and guest lectures from Industry professionals/HR/Placement Agencies/Technology vendors to interface the students with global industry trends Saneyee 27/04/2022

- To initiate research and development projects and shall carry out collaborative research in cement and construction industry.
- To carry out joint consultation and to provide solutions for technical complexities at post-graduate level and doctoral level research projects carried out at NITTTR Chd..

NOW THIS MEMORANDUM OF UNDERSTANDING (MOU) WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

The NITTTR Chd shall use the assistance, sponsorship or support provided by Dr. Fixit Institute of Structural Protection & Rehabilitation, Mumbai only for the purpose expressly stated in the MoU and not for any other purpose, unless otherwise agreed upon by both the parties. Further, Dr. Fixit Institute of Structural Protection & Rehabilitation, Mumbai may sponsor symposiums, workshops, technical presentations etc., to be conducted at the college, at its own discretion. Activities to be included in MOU

- Organizing Training programme, Technical workshops and Professional development programme on waterproofing and repairs for construction professionals.
- Skill development workshops for user's category in waterproofing and repair business.
- Establishing a state of art Resource cum Experience Centre for technology demonstration.

NOW AGREE TO PLAN AS FOLLOWS:

Both the parties agree that there shall be joint programmes in a year covering the following types of activities:

- Seminars and workshops on selected topics for information dissemination. a)
- Short-term (1-5 days) refresher courses for practicing engineers/teachers etc. b)
- Student's awareness programmes. c)
- Any other joint technology awareness activities. d)

The annual calendar of events shall be drawn up jointly through mutual exchange of ideas and perceived needs immediately on conclusion of this MOU.

Efforts will be made by both the parties to make the programmes financially self-supporting covering all expenses incurred individually by each party.

The prime roles of DFI-SPR shall be:

- To nominate an event coordinator.
- To nominate the experts / specialists / faculties in the concerned fields of technology.
- To provide course / presentation materials as required for the event.
- To provide training / demonstration kits.

The prime roles of NITTTR shall be:

- To provide infrastructure like seminars / training hall, projector, white board, computer, marker etc. in the NITTTR premises/Polytechnics etc. where facilities for conducting such programmes are available with NITTTR, Chandigarh.
- To publicize the programmes and ensure adequate participation.
- To arrange hospitality within budgetary provisions.
- To nominate a coordinator for each of the events.

The preparation of events agenda, publicity brochures, participation certificates etc. shall remain primarily as joint responsibilities.

This MOU shall be effective from the date of signing i.e. 27th April, 2022 and shall remain effective for five years. It can be further extended on mutual consent through exchange of written communications.

Neither party shall be responsible for any failure to carry out its commitment due to un-foreseen circumstances or to causes beyond their reasonable control, including but limited to acts of gods, riot, embargos and acts of civil or military authorities, fire, floods, energy labour or materials. In the event of any such delay, parties may defer the date of executing their responsibilities for a period equal to the time of such delay.

The agreement is valid for a period of five years with effect from the date of signing of the agreement and may be renewed after that period. MoU may be brought to an end during its period of validity by either party agreeing to do so with prior notice of 1 month and in writing.

DISPUTE RESOLUTION

Any dispute arising will be settled by mutual negotiation between the two parties.
