TO CONSIDER THE ANNUAL ACCOUNTS OF THE INSTITUTE FOR THE YEAR 2008-09.

TO CONSIDER AUDIT AND INSPECTION REPORT OF THE INSTITUTE FOR THE YEAR 2008-09.

The institute accounts for the year 2008-09 were audited by the Principal Accountant General (Audit) Punjab & U.T. Chandigarh from 18 to 22 May, 2009. The Audit and Inspection Report was issued by the Audit Office vide their letter No. OAD/Civil/Account/CHD/NITTTR/2008-09/119-20 dated 12.06.2009, a copy of which is placed as **Annexure - III** at Page No.16. The report does not point out any serious irregularity in the institute accounts. ITEM NO.F.15.6 TO CONSIDER ENHANCEMENT OF RE-IMBURSEMENT OF COST OF BOOKS AND TECHNICAL JOURNALS TO FACULTY MEMBERS.

The Government of India, Ministry of Human Resources Development vide their letter no.F.6/1-88-7-1 dated 28.2.1989 approved a scheme (part of pay scales revised by 4th Central Pay Commission) which, interalia, provided for reimbursement of cost of books/technical journals to faculty members and eligible Librarian up to a limit of Rs.1000/- per year. The Board of Governors, vide item B. 51.24 (Against Item No.F.22.29) of their 51st meeting held on 18.3.1989, approved the implementation of revised scales of pay for teaching faculty and concerned library staff at TTTI/NITTTR, Chandigarh.

The financial ceiling of Rs.1000/- per year was fixed about 20 years back. The prices of books and technical journals have increased manifold over this period. It is very difficult to purchase technical books/technical journals with this meager amount. There seems to be a need for reviewing this limit for upward revision to enable the faculty members to purchase the books useful in their relevant field. The financial limit, if approved, may be raised to Rs.3000/- per year.

ITEM NO.F.15.7 TO CONSIDER ENHANCEMENT OF SPECIAL DUTY ALLOWANCE BEING PAID TO THE INSTITUTE EMPLOYEE FOR PROVIDING SECRETARIAL ASSISTANCE TO THE CHAIRMAN, BOARD OF GOVERNORS AND OTHER INSTITUTE AUTHORITIES.

A ministerial employee of the institute is attached, on part time basis, with the Chairman, Board of Governors, to provide him secretarial assistance and also to support and assist the institute authorities for carrying out the official work related to the Chairman, Board of Governors.

The concerned official is required to do the allotted extra work in addition to his routine official duty, even during late office hours and on holidays. This extra duty also requires frequent movement of the official from the institute to the Office of the Chairman, Board of Governors.

The Board of Governors in its 95th meeting held on 16.06.2003 vide Item No.B.95.14 had approved a special duty allowance as an honorarium to the concerned employee on account of the said extra duties. The allowance has not been enhanced since 2003.

It is, therefore, proposed that the allowance may be enhanced to Rs.1,000/- per month keeping in view the rise in the cost of living as well as enhancement of various allowances by the Government of India on the recommendations of 6th Central Pay Commission.

ITEM NO. F.15.8 TO CONSIDER ENHANCEMENT OF MONTHLY REMUNERATION INCLUDING CONVEYANCE CHARGES OF DR PAWAN KUMAR KANSAL, INSTITUTE PART-TIME MEDICAL OFFICER AND THE PART-TIME DISPENSARY ATTENDANT.

The institute is running a part-time Dispensary in its premises to meet with the medical requirements of students, trainees and employees. A part-time qualified Medical Officer and a part-time Dispensary Attendant are engaged for the purpose. Presently Dr Pawan Kumar Kansal who is MBBS, MD(Medicine) with an experience of about 25 years, is the part-time Medical Officer of the Institute. He is a Cardiologist and Physician and presently working in the Mukut Hospital, which is a CGHS recognized hospital at Chandigarh.

The Board of Governors of the institute, on the recommendations of Finance Committee, had decided in its 14th meeting held on 26.06.2009, the following consolidated monthly remuneration for the Medical Officer & the Part Time Dispensary Attendant:

1.	Monthly consolidated fee including conveyance charges of Part Time Medical Officer	Rs.12,000/- per month
2.	Monthly consolidated fee including conveyance charges of Part Time Dispensary Attendant	Rs.3000/- per month

Since there is no sanctioned post of Part-time Dispensary Attendard in the institute, therefore the part-time Medical Officer is also requested to arrange a qualified person to work as part-time Dispensary Attendant in the Institute Dispensary. The part-time Medical Officer attends the Institute Dispensary for 1½ hours daily on each working day alongwith the part-time Dispensary Attendant. The part-time Medical Officer Dr Pawan Kumar Kansal has requested for enhancement of his monthly consolidated fee and monthly fee of Dispensary Attendant as under:

1.	Monthly consolidated fee of the Part- time Medical Officer including conveyance charges	Rs.20,000/- per month
2.	Monthly consolidated fee of the Part- time Dispensary Attendant including conveyance charges	Rs.4,000/- per month
