# ITEM NO.F.17.2.3 TO CONSIDER ENHANCEMENT AND GRANT OF FIXED MEDICAL ALLOWANCES TO THE CENTRAL GOVERNMENT PENSIONERS RESIDING IN AREAS NOT COVERED UNDER CGHS

The Government of India, Ministry of Personnel, Public Grievances & Pensions (Department of Pension & Pensioners' Welfare), vide its letter No.4/25/2008-P&PW(D) dated 25.05.2010, enhanced the Fixed Medical Allowance from Rs.100/- to Rs.300/- per month w.e.f. 01.09.2008 to the Central Government Pensioners residing in areas not covered under CGHS. It is proposed that the said orders be implemented for pensioners of this institute as this Institute does not provide any medical assistance to Retirees. A copy of the said Office Memorandum is attached as Annexure – VI at page No.61 for perusal.

## ITEM NO.F.17.2.4 TO CONSIDER MEDICAL AID TO RETIREES

The retirees of this institute, who are about 108 in numbers as on 30.06.2010, are pressing hard for medical aid for indoor treatment. It may be noted that Retirees of this institute are not entitled to any medical aid, except that fixed medical allowance of Rs.100/- per month. In this regard a meeting of retirees and existing employees was held on 09.06.2010 under the Chairmanship of the Director. A copy of minutes of meeting held on 09.06.2010 is attached as **Annexure-VII** at page No.62 for perusal.

#### The committee recommended:

- The matter may be taken up with Government of India, MHRD, for increasing the existing medical allowance of Rs.100/- p.m. to at least Rs.500/- p.m. in view of the increased cost of treatment. (This has been placed before Finance Committee vide item No.F.17.2.3 above).
- 2. Pensioners may be allowed reimbursement of indoor treatment at least to a certain limit (say Rs.50,000/-) in Institute's approved hospitals.
- Pensioners may be allowed to consult the Medical Officer of the institute free of cost provided they opt to forgo their fixed medical allowance.

# ITEM NO.F.17.2.6 TO REVIEW DELEGATION OF POWERS OF THE DIRECTOR

The Memorandum of Association of NITTTR Chandigarh, at Sr. No.2 provides Society's Objectives. Further, Sr.No.2 (xxii) (c) further mentions :

"to delegate all or any of its power to the Board of Governors of the institute. The Board may in turn delegate some of its powers to any of the committee or committees constituted by it, or to any officer of the Society."

Rule 15 of Rules and Regulations of NITTTR Chandigarh Society defines the roles & responsibilities of 'Director'. Further Rule 15(E) provides that 'Director shall have such other powers and perform such other duties as may be delegated or assigned to him by the Board'.

The Board of Governors in its 94<sup>th</sup> meeting held on 06.03.2003 vide item No.B.94.18 reviewed the delegation of powers. It has been felt that the powers of the Director may be reviewed as the Institute status has been upgraded to the level of National Institute from the year 2003. Moreover, the prices of store articles / goods have enhanced manifold since the last delegation was approved.

Therefore, the powers of the Director have been reviewed and a proposal for the revision of delegation of powers is placed at **Annexure–IX** at page Nos.64 to 79 for consideration.

It may be mentioned here that the said item was placed before the BoGs in its 16<sup>th</sup> meeting vide item No.B.16.4.3 which was deferred.
