It was apprised that such was the requirement under Rule 56(j) of Fundamental Rules and Supplementary Rules of Government of India on the

However, with respect to the decision of the BoGs taken in its 18th meeting held on 09.11.2010, the institute referred the matter to the MHRD vide letter dated 08.03.2011.

The Board members, while going through the rule, said that as per their interpretation, such screening be undertaken only in cases where there was some doubt that the employee was not either physically or mentally fit to continue beyond the age of 50 years. The Board, thus, was of the view and took the decision that screening of every staff member at the age of 50 years is not required to be undertaken any longer.

Sh.N.Mohan Das, Director (T) to GOI, MHRD, vide letter dated 16.05.2011 has replied that "institute may continue screening the employees as before in accordance with Govt. orders. However, the BoG may be bothered to view only the cases of those employees who are not found fit either physically or mentally to continue beyond the age of 50 years, after the said screening."

MEMBERS WHO HAD NOT OBTAINED PH.D
WITHIN 7 YEARS AS PRESCRIBED IN THE TERMS
& CONDITIONS OF THEIR SELECTION TO THE
POST OF ASSISTANT PROCESSOR

The AICTE vide letter No. No.F.No.FD/PSSC/Notification/2002/1 dated 19.02.2003 had laid down the following eligibility requirement for the post of Assistant Professor in the degree level technical institutions in various disciplines of education:

Ph.D degree with first class degree at Bachelor's or Master's level in the appropriate branch of Engineering/Technology with 3 years experience in Teaching/Industry/Research at the level of Lecturer or equivalent OR First class degree at Master's level in the appropriate branch of Engg./Tech. with 5 years experience in Teaching/Industry/Research at the level of Lecturer or equivalent. (Such candidates will be required to obtain Ph.D degree within a period of 7 years from the date of appointment as Assistant Professor)

Two faculty members namely Mrs. Lini Mathew, Associate Professor (earlier Assistant Professor) and Mrs. Poonam Syal, Associate Professor (earlier Assistant Professor) who were having Master's Degree in appropriate Branch of Engineering/Technology with 5 years of experience in teaching/industry/research at the level of Lecturer were appointed as Assistant Professor in February, 2004 with the condition that they have to obtain Ph.D Degree within a period of seven years from the date of appointment as Assistant Professor(now Associate Professor) as per the condition laid down in the above referred letter of AICTE dated 19.02.2003 for the appointment to the post of Assistant Professor.

The period of 7 years from the date of appointment as Assistant Professor in respect of these faculty members had since elapsed but these faculty members are yet to obtain their Ph.D degrees. It is worthwhile to mention here that in the above cited letter, no guidelines have been given as to what action the institute has to initiate in case an individual does not obtain Ph.D degree within the prescribed limit of 7 years, in case of appointment as Assistant Professor (now Associate Professor).

In this regard the institute vide letter No.NITTTR/Admn/E-1/33765 dated 17.02.2011(copy enclosed as **Annexure – V** at page Nos.11 to 12) had requested the Advisor, Approval Bureau, All India Council for Technical Education, New Delhi to intimate further action to be initiated in such cases. But no reply has been received till date.

THE BOARD OF GOVERNORS MAY KINDLY ADVISE THE ACTION TO BE INITIATED IN SUCH CASES WHEN INDIVIDUALS DO NOT OBTAIN PH.D. WITHIN STIPULATED PERIOD.

The selection committee met on the above dates and selected the candidates as per details given in UO No. NITTTR/Admn/RA/16 dated 27.5.2011.

Board of Governors may kindly approve the recommendations of the Selection Committees so that necessary appointment letters may be issued to the selected candidates.

ITEM No.B.20.3.5 TO CONSIDER RE-EMPLOYMENT OF FACULTY BEYOND THE AGE OF SUPERANNUATION

In order to meet the situation arising out of the shortage of teachers in Universities and other teaching institutions and the consequent vacant positions therein, Government of India has allowed re-employment of faculty beyond the age of superannuation i.e. after 65 years. As per this order the Government of India has prescribed the following guidelines for re-employment of faculty beyond the age of superannuation:

"All persons holding teaching positions against sanctioned posts may also be considered for re-employment beyond 65 years and up to the age of 70 years, against sanctioned vacant posts, if such posts are not filled up by regular candidates. However, such re-employments beyond the age of 65 years shall be done only after screening at the age of 65 years, under the extant guidelines of the University Grants Commission".

As per the guidelines of University Grants Commission the reemployment of faculty beyond the age of superannuation is as under:

"subject to availability of vacant positions and fitness, teachers shall also be re-employed on contract appointment beyond the age of sixty five years upto the age of seventy years. Re-employment beyond the age of superannuation shall, however, be done selectively, for a limited period of 3 years in the first instance and then for another further period of 2 years purely on the basis of merit, experience, area of specialization and peer group review and only against available vacant position without affecting selection or promotion prospects of eligible teachers".

Keeping in view the above guidelines, permission may kindly be granted for initiating the process for implementation of the scheme for reemployment of superannuated faculty beyond the age of 65. Board may consider for the approval for evolving institute specific policy after studying the rules and regulations in detail.
