This Institute is covered under World Bank assisted Project "Technical Education Quality Improvement Programme (TEQIP-II). One of the mandates, as per the guidelines mentioned in the Project Financial Management Manual (FMM), is to conduct the statutory audit of its accounts from a certified Chartered Accountant Firm.

The work of Statutory Audit of the accounts of TEQIP-II, for the financial year 2013-14 was awarded to M/s GSA & Associates "Chartered Accountants", New Delhi. The quotations were invited from various Chartered Accountants firms, the party M/s GSA & Associates quoted the lowest rate. Hence statutory audit was awarded to this firm vide our letter no. NITTTR/TEQIP/09 dated 16.07.2014. The audit was carried out as per the established standards/practices laid down by the Institute of Chartered Accountants of India and in accordance with the project guidelines.

The report did not point out any serious observation/findings. However, Audit suggested to ope separate bank account for TEQIP-II funds. In compliance to this audit observation, separate bank account for TEQIP-II has been opened with Oriental Bank of Commerce, Sector-26, Chandigarh.

#### ITEM NO. F.28.3.8 TO CONSIDER AND APPROVE THE LADY DOCTOR FOR GIRLS HOSTELS

The institute has 150 girls students inclusive of Ph. D students, ME regular and modular, STC participants, students trainees, project associates staying in the institute hostels. Many times, the institute faces medical emergencies, during night and holidays. There is no service of the part time Lady Doctor available in the institute to take care of these medical emergencies.

Looking into the emergency requirements, it is proposed that there is a need of part time Lady Doctor who will visit daily for 1-2 hours in the evening. Monthly consolidated fee including conveyance charges i.e.Rs.20,000/- will be paid. The expenditure will be met from Medical Fee charge from ME students (regular and modular) and rest can be supplemented by institute grants.

NITTTR, Chandigarh has signed a MOU with MNIT, Jaipur for undertaking collaborative projects and programmes for the benefit of both of the institutions. For enhancing the outreach of the programmes of NITTTR, Chandigarh, MNIT Jaipur will organise collaborative programmes for the faculty of the technical institutions in the state of Rajasthan in the areas where NITTTR, Chandigarh does not have the expertise and facilities.
