At the outset Dr OP Bajpai, Director and Member Secretary introduced the new Chairperson, Mrs. Rajesh Kumari who joined on December 01, 2004 and extended her a cordial welcome. He informed the house that Mrs. Rajesh Kumari comes to the institute from the education stream and is accordingly taking keen interest in the institute activities. Her valuable suggestions and ideas will help the institute to grow further.

Dr OP Bajpai also appreciated the contributions made by the Ex-Chairman Shri Yash Pal Mahajan, a dynamic personality, who had also shown keen interest in the institute activities and endeared himself with the faculty and staff by his amicable nature. The contributions of Shri Yash Pal Mahajan were reckoned as commendable and were sought to be placed on record. Thereafter Shri OP Bajpai introduced all the other members to the new Chairperson and welcomed them to the meeting.

Mrs. Rajesh Kumari, Chairperson conveyed her thanks to the Member Secretary and extended a warm welcome to all the members of the Board and expressed her deep gratitude towards them for having spared their valuable time for attending the meeting. She then requested Dr OP Bajpai, Director and Member Secretary to conduct the proceedings. Before taking up various agenda items, Dr. OP Bajpai, Member Secretary apprised the House about the major activities undertaken by the Institute since the last meeting i.e September, 2004. He informed as under:

- A National Seminar on "ICT Enabled Education" was held on 17 & 18
 November, 2004 in which 55 eminent persons from all over the
 Country participated.
- 2. The Annual Institute Day was celebrated on November 18, 2004 i.e date on which the institute has been registered under the new name.
- 3. As a result of the pursuant efforts, the Institute has been identified as one of the National Centres by ISRO for promoting Technical

Education through EDUSAT launched by ISRO/Department of Space. The institute intends to utilize EDUSAT facility for Credential Modular Based Post Graduate programmes and also for Faculty Development programmes. This initiative of the institute received appreciation and recognition from Mrs. Anuradha Gupta, IAS, Member Secretary, AICTE on her visit to the institute on 07 March, 2005 during which she envisioned a bigger role for the institute.

- 4. Presently the number of seats in all the six Post Graduate programmes being conducted by the institute are 80. The institute has taken up the case with the AICTE to increase the number of seats to 150. The institute is also processing the matter with the concerned authorities for obtaining Deemed University status.
- 5. The institute has prepared a Vision Document and submitted the same to the Ministry of Human Resource Development. Similar documents have been prepared by the other NITTTRs. A workshop is proposed at Chandigarh during April, 2005 in which 50-60 leading personalities from all over the country will participate so that a common national level Vision Document may be prepared for the NITTTRs. The ultimate objective is to make the Institute a Centre of Excellence for which a road map has already been prepared with a focussed plan of action.
- 6. Under the World Bank Tech Ed.Project preliminary work relating to Impact Study of Tech.Ed.III Project and Study on Utilization of Resources has been done.
- 7. The institute organized a programme on Accreditation of Technical Institutes which was attended by 94 faculty of engineering colleges from all over the country.

- 8. A visit of Ethiopian delegation to the institute, led by their Vice Minister for Technical and Vocational Education, was coordinated by EdCIL, to explore the possibilities of bi-lateral cooperation in technical and vocational education so as to strengthen higher education system in Ethiopia.
- MoU has been signed with Gian Jyoti of TQM and Entrepreneurship, Mohali in November, 2004 for providing academic guidance in development of quality learning resources for B.Tech. programme offered by them.
- 10. Operational Plan for 2005-2006 has been finalized.
- 11. The institute has conducted 258 programmes for polytechnics in which 4704 trainees participated, 56 programmes for engineering colleges in which 1287 trainees participated and 26 workshops in which 1458 participants came, during the period April 2004 to February 2005. The Institute has also designed curricula for 10 vocational courses and revised 14 curricula covering 140 subjects, developed 91 instructional materials including 58 video films and completed 24 Extension Services and Consultancy projects.

All the Board members appreciated the efforts and progress made by the Institute for promoting technical education and expressed the hope that the pace of growth will be sustained. Thereafter the various agenda items were taken up as under:

ITEM NO.B.3.0 NOMINATION OF SMT RAJESH KUMARI AS CHAIRPERSON OF THE BOARD OF GOVERNORS OF NATIONAL INSTITUTE OF TECHNICAL TEACHERS' TRAINING & RESEARCH(NITTTR), CHANDIGARH BY THE GOVERNMENT OF INDIA, MINISTRY OF HUMAN RESOURCE DEVELOPMENT.

The House welcomed new Chairperson Mrs Rajesh Kumari and expressed the hope that her valuable contributions will be helpful for further growth of the institute.

TO CONFIRM THE MINUTES OF THE 2ND MEETING OF THE BOARD OF GOVERNORS OF NITTTR CHANDIGARH HELD ON SEPTEMBER 29, 2004 AND TO REPORT ACTION TAKEN THEREON

The Member Secretary apprised the House about the ongoing Court case of PUDA Vs the Institute and explained the circumstances under which the retirement benefits i.e gratuity and leave encashment of Prof R Subramanian who was the Chief Co-ordinator in the said case and who superannuated on June 30, 2004, have been withheld. Brief history of the case was also circulated amongst the members, a copy of which is attached herewith as Annexure 'A'. The Member Secretary also apprised the House about the CWP filed by Prof R Subramanian in the High Court of Punjab & Haryana at Chandigarh for release of his retirement benefits which is being replied appropriately. After listening to the Member Secretary, the House unanimously resolved that Prof R Subramanian should cooperate with the Institute in preparing the requisite information for defending the case so as to safeguard the institute's interest. It was proposed that if necessary, an outside technical consultant may be engaged for the purpose.
