TO CONSIDER AND APPROVE THE PROGRESS OF EXPENDITURE UNDER PLAN AND NON PLAN AND TO CARRY OVER THE UNSPENT BALANCE UNDER PLAN AS ON 31.03.2007 TO NEXT FINANCIAL YEAR.

The Committee recommended that the unspent balance under Plan as on 01-04-2007, amounting to Rs.338.92 lacs (Rs.128.92 lacs + Rs.210.00 lacs) be permitted to carry over to the current financial year viz 2007-08 in view of the report submitted by the institute in the agenda items. The committee suggested that the institute should submit a claim to the Ministry for matching grant against Net Internal Resource Generation (IRG) under the Block Grant Scheme.

The Committee recommended that the ETV van bearing Registration No. CHW-7240 may be condemned in view of the report submitted by the institute in the agenda item and disposed of through open auction/sealed tenders. It was also suggested that the institute should prepare fresh proposal for the purchase of new vehicle against the condemned van and provide for its budget in the revised budget estimate for the current financial year 2007-08.
