^{*}Out of unspent balance of Rs.128.92 lac under Plan, the Institute has a committed liability (supply orders already placed) worth Rs. 122.66 lac.

In addition to above, the Ministry of HRD released on demand a sum of Rs. 210 lac vide their sanction letter No. 7-2/2006-TS.IV dated 26th March, 2007 under Plan for the construction of New Hostel Block and Additional Lecture Hall Complex as per approved plan submitted to the MHRD vide institute DO No. NITTTR/NC/11523 dated 02.06.2006. The MHRD has also conveyed approval vide their letter No. F7-13/2006-TS.IV dated 30th May, 2007 to utilize the additional grant of Rs. 210 lac exclusively for the construction of above buildings.

TO CONSIDER CONDEMNATION OF ETV VAN, REGISTRATION NO. CHW-7240.

The Institute had purchased a Swaraj Mazda Chassis on 24-03-1988 for an amount of Rs. 1,65,000/- (Rs One lakh sixty five thousand only) from M/S Swaraj Mazda Ltd., Chandigarh and it was allotted Registration No. CHW-7240 on 03-04-1988. chassis was converted into Electronic Field Production Van by M/s Sion Garage Private Limited, Bombay in 1990 at a cost of Rs. 3,50,000/- (Rs Three lakh fifty thousand only). for use by the ETV Department. During the year 2006-07, the van was put to inspection thrice for passing to MVI, Chandigarh. The MVI pointed out major defects in the vehicle and did not issue the road-worthiness certificate to the ETV van. A copy of their noting in this regard, on certificate of fitness form for transport vehicle, is attached herewith at Page Nos.7-8. The vehicle is more than 19 years old and needs major overhauling. The cost estimate given by Swaraj Mazda Authorized Service Centre for removing the faults pointed out by MVI, Chandigarh was approximately Rs. One lakh (copy attached). Since the ETV van is very old and is being used very sparingly, it was not economical to spend such a huge amount on its repair. Therefore the van was put to Vehicle Inspection Board of Chandigarh Administration for inspection. The board inspected the ETV van and recommended that the van be prematurely condemned and disposed-of as per institute rules. The reserved price of the van estimated by the said board is Rs 35,000/- (Rupees Thirty Five Thousand only).

Hence, the ETV van bearing Registration No. CHW-7240 may be condemned and allowed to be disposed-of through open auction/sealed bids.
