ITEM No. B.31.5.3 IRREGULARITIES IN THE APPOINTMENT OF Ms KANIKA SHARMA, ASSISTANT PROFESSOR, NITTTR, CHANDIGARH - DETAILED CASE

The above case was put up in the 28th meeting of the Board of Governors held at this institute on 01-10-2013 and the Board advised the institute to prepare a detailed case of Ms Kanika Sharma and send the same to the members for their comments.

In compliance of the above decision of the Board of Governors, the detailed case was sent to all the members of the Board for their comments vide institute letter No. NITTTR / Admn / RA / 30484 - 30497 dated 03-12-2013 and subsequent reminder dated 4-2-2014 (Copies Enclosed as Annexure – V at page Nos.21 to 35). The institute had received comments only from the two

board members namely Dr. N. Sathyamurthy, Director, IISER, Mohali and Shri SP Oswal, Chairman, Vardhman Group of Companies, Ludhiana (Punjab) which are reproduced below:

1.	Dr N. Sathyamurthy	I have looked at the papers sent to me along with the copy of the report of the fact finding committee. In view of the detailed observations of the committee and the conclusion that there was no serious irregularity in the documents presented, recommended that the case be closed.
2.	Shri S.P. Oswal	I have gone through the findings of the committee containing in Para 1 to 10, based on the queries raised by the complainant and also the recommendations given at the end. I am of the opinion that though there is an error in the disclosure of marks by the applicant but that does not debar the applicant from inviting for interview. In my view it does not amount to suppression of the fact that could vitiate the process of fair selection adopted by the selection committee. The rest of the allegations do not hold much ground. Therefore, the allegations of irregularities as alleged by the complainant have not been proved to justify any action.

It is also stated that the institute has received a communication from Ministry vide letter No. 7-3/2012-TS.IV dated 27-1-2014 conveying that the committee already constituted for this case may also look into the letter dated 05-01-2012 of Ms Parul Rajput, resident of House No. 144-S, Model Town, Hisar (Haryana) and the recommendations of the committee be submitted to the Board of Governors. Accordingly the committee again met on 26-03-2014 and looked into the letter dated 5-1-2012 of Ms Parul Rajput and made recommendations which are enclosed as Annexure – VI at page Nos.36.

The Institute in its 30th meeting (vide item No. B 30.5.8) held on 2.6.2014 had informed the Board of Governors of this institute that two faculty members namely Mrs. Rama Chhabra and-Mr. Suresh Kumar Gupta whose were having Master's degree and completed 5 years service at the level of Lecturer (senior scale) but not having Ph.D were promoted as Assistant Professor under Career Advancement Scheme subject to the condition that they will complete their PhD within a period of seven years.

The Board of Governors after discussing the issue at length directed the institute to convey the faculty members to complete their Ph.D which was an essential condition for their being designated as Assistant Professor and ask the faculty members why action should not be taken against them for not completing the Ph.D within the specified period of seven years from the date of their being designated as Assistant Professor.

In compliance of the above decision of the Board of Governors both Mrs Rama Chhabra and Mr. Suresh Kumar Gupta were conveyed the above decision of the Board of Governors vide letter dated 11 July 2014 and had asked to explain as to why they have not completed their Ph.D within the prescribed limit and what is the present status. They were also advised to submit the progress report from their guide also within a period of 10 days from issue of letter i.e. by 21 July 2014.

In response to the above both the above faculty members have replied as under:

In view of the above both the faculty members have informed that the condition of doing Ph.D is no more applicable in their case.

The pointwise reply of the institute against the reply of Mrs Rama Chhabra and Mr. Suresh Kumar Gupta is as under:

Reply of Point No.1: As per AICTE guidelines DATED 31.7.2001 for eligibility to move into the grade of Lecturer(Selection Grade)/Assistant Professor, the minimum length of service as Lecturer(Senior scale) shall be uniformly five years.

Lecturers in the Senior Scale who do not have a Ph.D degree or equivalent published work, and who do not meet the scholarship and and research standards, but fulfils the other criteria given for the post of Asstt. Professor, and have a good record in teaching and, preferably, have contributed in various ways such as to the corporate life of the institution, examination work, or through Research & Extension activities, will be placed in the Selection Grade, subject to the recommendations of the Selection Committee which is the same as for promotion to the post of Asstt. Professor. They will be designated as Lecturers in the Selection Grade. They could offer themselves for fresh assessment after obtaining Ph.D. and/or fulfilling other requirements for promotion as Asstt. Professor and if found suitable, could be given the designation of Asstt. Professor.

Both the faculty members were promoted as Lecturer (Selection Grade) in the pay scale of Rs. 12000-18300 as per the above rules. In the promotion orders it was mentioned that the promotion is subject to the terms & conditions of Career Advancement Scheme issued by AICTE vide notification dated 31.7.2001 as well as clarifications amendments issued from time to time by the AICTE.

Reply to Point No.2: As per AICTE guidelines dated 17.12.2003 a Lecturer in the senior scale will be eligible for promotions to the post of Assistant Professor if he/she has Master's degree and complete five years of service at the level of Lecturer (senior scale). Those who do not have Ph.D

degree, they are required to obtain PhD degree within a period of seven years from the date of his/her promotion to the post of Assistant Professor.

AICTE notification dated 31.7.2001 as well as clarifications amendments issued from time to time are enclosed as **Annexure – VIII** at page No.38 to 46.

Reply to Point No.3: 6th pay commission and AICTE guidelines provides that incumbent Assistant Professor and incumbent Lecturers selection grade who have completed 3 years in the pre-revised scale of Rs.12000-18300 on 1.1.2006 shall be placed in pay band of Rs.37400-67000 with AGP of Rs.9000 and shall be re-designated as Associate Professor.

Mr Gupta was granted selection grade on 28.4.2003 vide office order No. 130 dated 4.6.2003 and was promoted as Assistant Professor(in situ) on 2.12.2006 vide office order No.191 dated 7.12.2006. He had completed 3 years in the pre revised scale of Rs.12000-18300 on 28.4.2006. He was placed in pay band of Rs.37400-67000 with AGP of Rs.9000 and was re-designated as Associate Professor wef 28.4.2006 vide office order No. 192 dated 14.10.2009.

Similarly Mrs Rama Chhabra was granted selection grade on 22.3.2004 vide office order No.87 dated 2.4.2004 and was promoted as Assistant Professor (in situ) on 02.12.2006 vide office order No.191 dated 7.12.2006. She had completed 3 years in the pre revised scale of Rs.12000-18300 on 22.3.2007. She was placed in the pay band of Rs.37400-67000 with AGP of Rs.9000 and was redesignated as Associate Professor wef 22.3.2007 vide office order No, 192 dated 14.10.2009.

Both the above faculty members were placed in pay band of Rs.37400-67000 with AGP of Rs.9000 and were re-designated as Associate Professor because they had completed 3 years in the pre-revised scale of Rs. 12000-18300 either by promotion as Lecturer selection grade or as Assistant Professor.

Since in the new guidelines, nowhere it has been mentioned that the clause which was imposed as per old AICTE guidelines have been withdrawn and the faculty members who have been placed in pay band of Rs.37400-67000 with AGP of Rs.9000 and re-designated as Associate Professor as per sixth pay commission need not to do Ph.D.

ITEM No.B.31.5.6 TO CONSIDER FURTHER EXTENSION AS PROFESSOR (RE-EMPLOYED) TO PROFESSOR Y.K.ANAND

The Board of Governors in its 25th meeting (vide item No. B 25.,4.3) held on 23.6.2012 had approved reemployment of faculty beyond the age of superannuation on contract basis for a period of one year on consolidated salary of Rs.50,000/- per month without giving any other benefit. In compliance of the above decision of the Board of Governors, Dr,Y.K.Anand who was working as Professor Media Centre and superannuated on 31.01.2012 was reemployed as Professor after attaining the age of superannuation vide appointment letter No..NITTTR/Admn/R-2/17984-87 dated 22.8.2012 on contract basis on a consolidated salary of Rs.50,000/- per month for a period of one year. In response to the above institute letter dated 22.8.2012, Dr.Y.K.Anand had joined as Professor (re-employed) on 22.8.2012(FN). His one year term had ended on 21.8.2013. On the request of Dr.YK Anand, his term of contractual appointment was further extended beyond 21.8.2013 for one more year on the same terms and conditions with the approval of Board of Governors accorded in its 28th meeting(Item No. B 28.4.5) held on 01.10.2013. His extension of one year as approved by Board of Governors ended on 21.8.2014. Dr.Y.K. Anand vide his letter dated 7.8.2014 has stated that he is interested to continue contributing to Faculty Development Programme and projects of following departments/areas and requested to grant extension in his term as re-employed Professor:

- i) Curriculum Development Centre
- ii) Media & continuing Education Centre
- iii) Entrepreneurship Development & Industry-Institute Interaction Department
- iv) Rural Development
- v) Mechanical Engineering
- vi) Education & Educational Management(ICT Programme)
- vii) ME(Post Graduate in Engineering & Technology)
- viii) Extension and Research Work for national and state level

Dr.YK Anand vide his letter dated 7.8.2014 has requested that he may be given further extension (preferably for three years as prescribed in UGC recommendations of reemployment of superannuated Professor and also extend other facilities like Medical, Transport etc as given by NITTTR, Bhopal to their reemployed faculty)

Since Dr. YK Anand was looking after the NBA work and it is now mandatory to have NBA and else money will not be released from TEQIP. On the above request of the Institute, the Chairman, Board of Governors vide UO No 28 dated 13.9.2014 had allowed extension to Dr.Y K Anand beyond 21st August, 2014 till the next Board of Governors meeting on the same terms & conditions.

Keeping the above in view, the Board of Governors may kindly give directions regarding further extension and service conditions to Dr. YK Anand .

TO CONSIDER THE REQUEST OF DR. HEMANT SOOD FOR PAY FIXATION CONSEQUENT UPON HIS PROMOTION AS PROFESSOR UNDER CAREER ADVANCEMENT SCHEME

The pay fixation case of Dr. Hemant Sood consequent upon his promotion as Professor under Career Advancement Scheme was placed in the Board of Governors in its 30th meeting(vide item No.30.5.5) held on 2.6.2014.

The Board of Governors in the above meeting had directed the institute to re-place the case to the Board of Governors after giving details of the faculty who have been given promotions under Career Advancement Scheme, in the past, from the date of selection committee meeting and the basis for the same.

In this regard it is submitted that in the past all the faculty have been given promotion under Career advancement scheme from the date of selection committee meetings on the basis of Govt. of India DO Letter No.7-19/2002 TS.IV dated 19 September, 2002. The details of above cases are as follows:

In pursuance to the AICTE notification No. F.No.37-3/Legal/2010 dated 5th March, 2010 and F.No.37-3/Legal/AICTE/2012 dated 8th November, 2012 and the decision of the Board of Governors taken by item No. B 27.5.7 of 27th meeting held on 26.4.2013, the meetings of the Screening –Cum Evaluation Committee(s) for upward movement cases of Assistant Professor under Career Advancement from AGP Rs.6000 to AGP Rs.7000 and AGP Rs.7000/- to AGP Rs.8000/-were held on 23.07.2014 in the Institute. The recommendations of Screening-Cum Evaluation Committee were sent to Chairman, Board of Governors for approval vide UO

No.NITTTR/Admn/23 dated 30.07.2014. The Chairman, Board of Governors had approved the recommendations of the Screening-Cum Evaluation Committee on 27.8.2014 except the case of Mrs Ritula Thakur. The Chairman, Board of Governors had approved upward movement of the eligible Assistant Professors except Mrs. Ritula Thakur, who was on study leave to USA and had interaction with the Screening –cum-Evaluation Committee on 23 July 2014 through skype.

The Chairman, Board of Governors had directed that the case of Mrs Ritula Thakur, Assistant Professor, Electrical Engineering Department for upward movement under Career Advancement Scheme be put up in the Board meeting since it was first experience of screening cum evaluation over skype. Accordingly the same is being placed for consideration and approval.

ITEM No.B.31.5.10 TO CONSIDER AND APPROVE THE PERFORMANCE AUDIT REPORT OF TEQIP-II

National Project Implementation Unit (NPIU) of Ministry of Human Resource Development (MHRD) reviewed Performance Audit Reports of Institutions participating in Technical Education Quality Improvement Programme, Phase-II (TEQIP-II) to assess progress made by all project institutions to achieve academic excellence. NPIU has sent the review report vide letter no. AC/TEQIP-II/PA/2014-15/764 dated 11-09-2014 (copy enclosed as Annexure - X at page No.70 to 71). As indicated in the report, NITTTR, Chandigarh has been rated as "A" grade in overall rating. This is an appreciable progress towards achieving academic excellence. The report is being uploaded on Institution website as desired by NPIU.

ITEM No.B.31.5.11 TO CONSIDER AND APPROVE THE SETTING UP OF NITTTR, CHANDIGARH EXTENSION CENTRES

With the expansion of technical education in the country, a large number of technical institutions have come up in all the states resulting in increased requirements of training of teaching faculty and technical supporting manpower. In order to meet the increased need for training and other requirements of technical education, it is proposed to set up Extension Centres of NITTTR, Chandigarh in northern states to undertake the following activities for technical institutions in respective states:

- 1. Conduct of training programmes for faculty and supporting staff.
- 2. Conduct of training programmes under Skill Development Mission.
- Conduct of training programmes under NMEICT.
- Implementation and monitoring of GOI schemes like CDTP, Mainstreaming of PWDs in TVET system, Strengthening of Polytechnics, Opening of new polytechnics in the States, etc.

For setting up the Extension Centres of NITTTR Chandigarh at Lucknow and Jodhpur, Institute has already sent the request to respective state governments to allocate required space (covered area). Similar action will be taken to set up Extension Centres in other states also.

As per recruitment rules duly approved by the Board of Governors in its 17th meeting held on 28-7-2010, the post of Junior Electronics Engineer is to be filled on 100% by promotion on seniority-cum-fitness basis amongst STA drawing Grade Pay of Rs 4200/- subject to fulfilment of minimum educational qualifications and experience prescribed for the post, failing which by open selection. Now one post of Junior Electronics Engineer is going to fall vacant on the superannuation of Shri Jaipal Singh, present incumbent, on 31-10-2014. As indicated in the Table Shri Jasvir Singh Rattan is the senior most STA but he does not fulfil the relevant qualification for the post of Junior Electronics Engineer, although he is diploma (Civil), B.E (Civil) and M.Tech. (Civil Engineering). Shri Jasvir Singh vide his letter dated 26-9-2014 has requested the institute to consider his case for the post of Junior Electronics Engineer as he is senior most amongst Senior Technical Assistants.

BOARD OF GOVERNORS MAY KINDLY CONSIDER AND ADVISE

ITEM No. B.31.5.13 TO CONSIDER FILLING UP THE POST OF CHIEF LIBRARIAN - REGARDING

The institute has two sanctioned post of Senior Librarian and Chief Librarian (sanctioned in the 6th meeting of Finance and Personnel Committee held on 10-11-1983. The post of Chief Librarian is

lying vacant since 3rd September, 2008. The above post could not be filled up due to imposition of ban by the Government of India on recruitment against vacant non-faculty posts until the ratio between faculty and non faculty posts comes to 1:1.1. An item for filling up of this post was placed in the 15th meeting of the Board of Governors held on 11-10-2009 and the Board of Governors resolved as under:

While approving this item, the Board suggested that the proposal may now be sent to the Ministry for its concurrence before initiating the process of recruitment.

Accordingly the institute requested the Ministry for allowing the institute to fill up the above post as the academic work of the institute has increased a lot in the past few years because of starting of regular and modular M.E Programmes and Ph.D programmes, besides increase in the number of short term courses and the number of participants. The last reminder was sent to Ministry for filling up several posts including the post of Chief Librarian vide this institute letter No. NITTTR/Admn/RA/15295 dated 28.07.2014.

It is worth mentioning that AICTE in its 5th & 6th Pay Commission guidelines have given the pay scales and career advancement scheme for library staff similar to faculty positions. It is also to add here that the Board of Governors of the institute in its 50th meeting vide Item No. 50.11 has resolved as under:

"The Board of Governors approved that Chief Librarian and Senior Librarian at the institute who are in the pay scale of Assistant Professor and Lecturer respectively be granted the privileges and facilities at par with teaching faculty with the condition that they will not be entitled to vacation".

Keeping the above facts in view, it is proposed that the post of Chief Librarian and Senior Librarian be delinked from non-faculty positions and considered similar to faculty positions as can be perceived from the reports of 5th & 6th Pay Commission's guidelines of AICTE. Board of Governors may kindly consider the above proposal and permit the institute to fill up the post of Chief Librarian as per the regulations of AICTE.
