ITEM NO.B. 93.26 TO REPORT ABOUT THE CIVIL SUIT FILED BY PUDA AGAINST INSTITUTE AND TO CONSIDER AND APPROVE

PAYMENT OF ENHANCED FEES OF RS. 40,000/- TO THE INSTITUTE COUNSEL FOR PLEADING THE CASE.

Hearing of the case took place on 20th December, 2004. There is no progress in the case and the date for next hearing has been fixed for 23rd March, 2005. The court has directed PUDA to produce evidence in support of their claims. It is also stated that Prof. R. Subramanian, former Prof. and Head, Civil Engineering Department and Chief Coordinator (superannuated on 30.6.2004) of the Project of PUDA Consultancy was asked to submit all the relevant documents pertaining to the case for taking proper defence but he could not hand over the same so far. Consequently his gratuity amounting to Rs. 3,50,000/- and leave encashment Rs. 3,50,054/- are lying withheld so as to safequard Institute's interest. Prof. R. Subramanian has filed a CWP No. 2065/2005 in the High Court of Pb and Haryana for release of his withheld retirement benefits.

TO CONSIDER INTER-SE-SENIORITY OF THE FACULTY PROMOTED IN-SITU THROUGH CAREER ADVANCEMENT SCHEME OF AICTE VIS-A-VIS RECRUITED DIRECTLY THROUGH OPEN SELECTION.

In response to this Institute's letter No. NITTTR/Admn/EA-1/8282 dated 12.8.2004, the MHRD, Department of Secondary & Higher Education, New Delhi vide their letter No. F.7-14/2004.TS.IV dated 29.12.2004 has informed that the matter was considered and examined in consultation with IFD of the Department. The IFD is of the view that direct recruits would rank senior to promotees under ACP. There is no question of determining inter-se-seniority as both are to be treated as distinct group.

However, if for any post, the recruitment specifies that certain percentage of vacancies shall be filled by direct recruitment and remaining percentage by promotion, then interse-seniority shall be determined with reference to quota-rota system.

All the sanctioned posts of faculty including Professors in this Institute are filled up by direct recruitment through open selection only. Advice of the Ministry has been accepted and implemented.

TO CONSIDER PROVISION OF ADDITIONAL FACILITIES OF STAFF CAR AND INSTITUTE RESIDENTIAL HOUSE FOR THE CHAIRPERSON, BOARD OF GOVERNORS.

The post of Chairperson, Board of Governors of the Institute is an honorary post and the Chairperson is nominated by the Government of India. ITEM NO. B.3.13 TO RATIFY THE ACTION TAKEN BY THE CHAIRPERSON. BOARD OF GOVERNORS WITH RESPECT POLICY/CRITERIA FOR ALLOWING THE INSTITUTE EMPLOYEES FOR DOING FULL TIME/PART-TIME ME/ M.TECH DEGREE AT THE INSTITUTE.

The institute has prepared the following policy/criteria for allowing the institute employees for doing full time/part time ME/M-Tech at the institute.

- Every institute employee should make all out efforts for getting admission 1. in ME/M. Tech programme in an outside institute of higher learning and it is not possible to secure a seat outside, only then admission in the institute may be tried.
- There should not be any relaxation in the eligibility criteria for admission to 2. the internal candidate.
- The employee must render atleast two years service at the institute on the 3. scheduled date of commencement of the programme.
- Such employee should not be allowed to be engaged in the conduct of ME 4 classes at the institute both theory and practical. Other duties like conducting of STCs and other programmes of the institute may be assigned to such a person.
- Preference may be given to those employees who are below the age of 50 5. years.
- Not more than one faculty member of a Department may be allowed 6 admission at a time.
- The admitted employee will be liable to pay University charges but he may be exempted from paying tuition fee.
 - Such employee should execute a Bond to serve the institute for atleast 8. three years after completion of the programme failing which he will have to pay an amount of Rs. 2 lac to the institute as penalty.
 - The department will not be provided any substitute of such a 9 faculty/employee on regular or adhoc basis.

It has been approved by the Chairperson vide UO No.08 dated 10.3.2005 a copy which is attached as Annexure - VII.
