ITEM NO.B.34.3.2 TO CONSIDER AND APPROVE THE ANNUAL REPORT OF THE INSTITUTE FOR THE YEAR 2014-2015

The Member Secretary informed the House that the institute has received the Audit Certificate from Audit Office on 06.11.2015. The House deliberated upon it and was satisfied with the observations of the Audit party. The same has been incorporated in the Annual Report of the Institute.

The Board of Governors approved the Annual Report of the Institute for the year 2014-15, which shall be sent to Ministry for placing the same on the table of Parliament by December 31, 2015.

TO CONSIDER AND APPROVE OPENING OF THE BRANCH OF STATE BANK OF PATIALA IN THE INSTITUTE CAMPUS

The Board of Governors approved the proposal of the Institute of opening the Branch of the State Bank of Patiala in the institute campus. However, it advised the institute to obtain fare rent certificate from CPWD for comparison of rent being proposed to be charged from the Bank. In addition, Board of Governors advised the institute to put an exit clause with a three months notice in the Memorandum of Understanding to be signed with the Bank.

TO CONSIDER AMENDMENT OF RECRUITMENT RULES OF THE INSTITUTE RELATING TO PROMOTION OF NON TEACHING EMPLOYEES

The Member Secretary placed the Recruitment Rules prepared by the Institute for the promotion of the non-teaching employees of the institute. The Board of Governors approved these rule and directed the institute that before sending these rules to MHRD for approval, Recruitment Rules shall be put up before the Committee of Directors of all four NITTTRs constituted by Govt. of India, MHRD, New Delhi, vide letter No. F.No.23-5/2015-TS.IV dated 17th November, 2015 for framing uniform Recruitment Rules for all the NITTTRs.



TO CONSIDER AND APPROVE THE RECOMMENDATIONS OF THE SELECTION COMMITTEES FOR POST OF ASSISTANT PROFESORS AGAINST ADV. No.99/2015

The Member Secretary informed the Board that a letter has been received from the Ministry of Human Resource Development forwarding a complaint regarding recruitment. The Board considered the letter. The Member Secretary of the Board presented all the relevant documents pertaining to the complaint and the reply framed to it. The Board was of the opinion that the facts represented in the complaint are misrepresented and not true. It further decided as under:

- 1. The Institute should send the same response (parawise reply) to the Ministry.
- 2. It kept the faculty recruitment process on hold till the ministry's response is received.
- The Board authorised the Chairman, Board of Governors to approve the recommendations of the Selection Committees on receipt of instructions from the Ministry.

TO CONSIDER AND APPROVE THE PROPOSAL FOR ESTABLISHING CLEAN TECHNOLOGY AND SUSTAINABLE DEVELOPMENT CENTRE

The Board of Governors in principle approved the setting up of Clean Technology and Sustainable Development Centre at the institute.

TO CONSIDER REPRESENTATION OF DR. MRS POONAM SYAL FOR RESTORATION OF INCREMENT

The Board of Governors did not accede to the request of Mrs Poonam Syal regarding restoration of her increments which were stopped due to her non completion of Ph.D within a stipulated time period of seven years.
