**ITEM NO.B.16.4.3 TO REVIEW DELEGATION OF POWERS OF DIRECTOR OF NITTTR**

The Memorandum of Association of NITTTR Chandigarh, at Sr. No.2 provides Society's Objects. Further, Sr.No.2 (xxii) (c) further mentions :

"to delegate all or any of its power to the Board of Governors of the institute. The Board may in turn delegate some of its powers to any of the committees constituted by it, or to any officer of the Society."

Rule 15 of Rules and Regulations of NITTTR Chandigarh Society refers 'Director'. Further Rule 15(E) provides that 'Director shall have such other powers and perform such other duties as may be delegated or assigned to him by the Board'.

The Board of Governors in its 94<sup>th</sup> meeting held on 06.03.2003 vide item No.B.94.18 reviewed the delegation of powers. It has been felt that the powers of the Director may be reviewed as the Institute status has been upgraded to the level of National institute from the year 2003. Moreover, the prices of store articles / goods have enhanced manifold since the last delegation was approved.

Therefore, the powers of the Director have been reviewed and a proposal for revision of delegation of powers is placed at **Annexure – XII** at page Nos.59 to 74 for perusal and approval of the Board of Governors.

**TO CONSIDER AMENDMENT IN HOUSE  
ALLOTMENT RULES REGARDING ELIGIBILITY  
CRITERIA FOR ALLOTMENT**

The Central Civil Services (Revised Pay) Rules, 2008, notified by the Government of India, Ministry of Finance, Department of Expenditure vide No.GSR-622(E) dated 29.08.2008, have been implemented for the institute employees with the approval of the Board of Governors/Ministry of Human Resource Development.

The existing eligibility criteria for the house allotment was notified on the basis of pay range before 1.1.2006. Consequent upon the revision of pay scales of faculty and staff, there is a need to refix the eligibility criteria for allotment of various types of Institute houses. The existing and proposed criteria for the allotment of these houses are as under :

BOARD OF GOVERNORS MAY KINDLY CONSIDER AND APPROVE THE PROPOSED ELIGIBILITY CRITERIA FOR HOUSE ALLOTMENT

**ITEM NO.B.16.4.5 TO CONSIDER AND APPROVE CHANGE IN DESIGNATION OF MULTI SKILLED ATTENDANT TO SKILLED WORK ASSISTANT.**

The Board of Governors in its 13<sup>th</sup> meeting held on 13.02.2009 vide item No.B.13.4.1, on the recommendations of Finance Committee, had approved the new designation of Daftri / Head Peon / Peons / Wardboys / Guest Room Attendant / Head Malis / Malis / Mazdoor / Head Sweeper / Sweepers / Head Chowkidar / Chowkidars and Library Attendant as Multi Skilled Attendant because of revision of their pay structure as per recommendations of 6<sup>th</sup> Central Pay Commission.

The Employees Union of the institute has, however, been requesting to change the designation from 'Multi Skilled Attendant' to 'Skilled Work Assistant' as proposed by the 6<sup>th</sup> Central Pay Commission under para 3.7.9(v) which reads as under :

"Appropriate designation can be devised by individual departments for the erstwhile Group D posts placed in PB-1. Alternatively, a common designation of Skilled Work Assistant can be extended to this category."

On the request of the Union, a committee was constituted to look into the matter. The committee recommended that the 'Multi Skilled Attendants' be re-designated as 'Skilled Work Assistants' as proposed by the Sixth Central

Pay Commission. Accordingly the designation of 'Multi Skilled Attendants' is changed as 'Skilled Work Assistants.'

**ITEM No. B.16.4.6 TO CONSIDER & APPROVE CONTINUATION OF PRESENT MESS/CANTEEN CONTRACTOR TILL FINALIZATION OF NEW CONTRACT PROCESS IS COMPLETED**

The Contract for the Mess and Canteen Services extended in September 2008 was to expire in September 2009. The press note for expression of interest was invited in September 2009. Only two parties responded out of which one was the existing contractor and one from Panchkula. A committee comprising of Prof. JS Saini, Prof. Ajay K Duggal and Sh. RK Malik visited the work premises where the 2<sup>nd</sup> party namely "The kitchen" has indicated their place of current working. However, it was found that the party has ceased to provide catering services. Therefore, the committee recommended to retender the case.

Expression of interest was published again on 25.10.2009. Two parties expressed their willingness to work; one was the existing contractor and the other party was M/S Millennium catering services. The tender documents were issued to both the parties. Both the parties submitted their financial bids and the case were processed in accounts section. The department recommended the award of the contract to one party which was found to be overall lowest. The case was marked to purchase committee for the finalization of the tender. Purchase committee again recommended for fresh tender at National level with wider publicity giving more specific details.

Thus the award of new tender could not be finalized despite repeated efforts. Since catering services are essential requirement, the extension to the

present contractor was made twice. Further extension was given up to January 15<sup>th</sup>, 2010 on prevailing contract rates and second extension has been made till the finalization of new contract on revised rates w.e.f. February 10, 2010.

Press tender was issued again and "Expression of interest" invited. Two parties have participated and the case is under progress.

BOARD MAY ALLOW EXTENSION TO PRESENT CONTRACTOR TO CONTINUE AT ENHANCED REVISED RATES TILL FINALIZATION OF PROCESS OF CONTRACT IS COMPLETED

The Government of India, Department of Personnel and Training vide O.M. No. AB-14017/32/2009-Estt (RR), dated 07-10-2009 issued Model Recruitment Rules for the post of Lower Division Clerk, a copy of said letter is attached as **Annexure-XIII** at page no.75 to 77. The Board of Governors of this institute in its first meeting vide Item No. B.1.15 held on 02.05.1967 had approved qualifications and experience etc. for the post of Lower Division Clerk at the institute. A comparative chart of existing and proposed rules are attached as **Annexure-XIV**, at page Nos.78 to 81, for kind perusal of the Board of Governors.

BOARD OF GOVERNORS MAY ALLOW TO IMPLEMENT LATEST MODEL RECRUITMENT RULES AS ENVISAGED BY GOVERNMENT OF INDIA IN LETTER DATED 07.10.2009.

TO CONSIDER SERIOUS VIOLATIONS IN  
IMPLEMENTING VARIABLE HIGHER RATE OF  
INCREMENT TO THE OFFICERS OF PB-3  
(RS.15600-39100)

The Central Civil Service(Revised Pay) Rules, 2008 notified vide Ministry of Finance, Department of Expenditure No.GSR 622(E) dated 29.08.2008 have been implemented for the institute employees with the approval of the Board of Governors. Rule 9 of CCS(Revised Pay) provides that the variable increment i.e 3% to 4%(1% above the normal rate) will be granted to not more than 20% of the strength of officers in PB-3.

In view of the 9 of CCS(Revised Pay) Rules, 2008, Mr. KL Singla, Senior Administrative Officer of the institute proposed various parameters to the then Director, Prof SC Laroia, based on the evaluations of Annual Confidential Report of the Officers in PB-3 for the grant of higher rate of increment i.e 4% (1% above the normal rate of increment). This proposal was approved by the then Director and shown to the then Chairman, Board of Governors.

On the basis of the above proposal, higher rate of increments i.e 4% was sanctioned to 25%(2 out of 8) officers of PB-3 for the years 2005-06 (beginning from July 1,2006 for the period January – June, 2006), 2006-07 and 2007-08 on 31.10.2008. The Senior Administrative Officer himself was one of the beneficiaries in each year.

The higher rate of increment for the year 2008-09 was also sanctioned to two officers on 26.6.2009, one of them was again Senior Administrative Officer, just five days before joining of the present Director.

It was later on brought to the notice of the present Director that Department of Personnel & Training, Government of India vide its OM No.1/1/2009-Estt.Pay I dated 03.07.2009, has invited suggestions from various Ministries/Departments for formulating/finalisation guidelines for grant of higher rate of increments to the officers of PB-3. This, in other words, means the institute should have waited for the guidelines to come from the ministry and should not have gone for such hasty implementation of this variable increment issue.

In the light of the above, a Committee was constituted to examine the cases of higher rate of increments sanctioned from the year 2005-06 to 2008-09 for higher performance to the officers of PB-3. The Committee opined that since the Government of India is in the process of formulating guidelines in this regard, the institute may await the same. Further, where the higher rate of increment has already been granted, such cases may be reconsidered for refixation of their pay in the revised scales at the normal rate of increment i.e 3%.

Taking stock of the whole case, it is found that the following irregularities are made:

1. The proposal was not initiated by the office but by the Senior Administrative Officer who himself was a beneficiary in all four years.
2. The higher rate of increment was granted in tearing hurry as the proposal was made on 30.10.2008, approved by the Director on 31.10.2008, shown to the Chairman and office orders were issued on the same day.
3. The Chairman, Board of Governors, has been delegated the powers of the Board which are to be exercised only in emergent cases. The emergency in the instant case has not been specified.

4. As per delegation of powers by Board of Governors, a decision taken by the Chairman has to be reported and ratified by the Board in the next meeting of the Board of Governors which had not been done even though two meetings of the Board were held before the joining of the present Director.
5. The higher rate of increment has been granted to 25% of PB-3 officers (two out of eight) when it is specifically provided that higher rate of increments are to be granted to not more than 20% of officers of PB-3.
6. The revised pay scales have been implemented from 01.01.2006 whereas, in the instant case, higher rate of increment for the year 2005-06 (Increment from 01.07.2006) too was granted taking into account the performance during the period from 1 April, 2005 to 31 December, 2005 when revised pay scales were not applicable at all.
7. Later on, the Senior Administrative Officer, in his own signature, wrote a letter to the Secretary, Government of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training) New Delhi with a copy to Deputy Secretary, Government of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training) without the approval of the present Director requesting him not to re-open the cases of the institute.

The higher rate of increment, i.e. 1% over and above the normal rate of 3%, drawn by the Senior Administrative Officer alongwith other officers for four years i.e. from the year 2005-06 to 2008-09 resulted in increase in the basic pay of these officers besides other allowances such as DA, etc. This is a recurring benefit which would accrue to them every month during the entire period of service and would also lead to higher amount of pension, gratuity, leave encashment, etc at the time of retirement and even after retirement, by way of enhanced pension. Needless to say, public money running in lakhs of rupees would have been drawn from the Government exchequer, had this gross violation not been detected and necessary actions not been taken.

In view of the above, the following decisions have been taken :

1. To withdraw the higher rate of increments sanctioned to the officers of PB-3 for higher performance for the year 2005-06(beginning July 1,2006 for the period January-June, 2006) to 2008-09.
2. To re-fix their pay by allowing normal rate of increment i.e 3%.
3. To make recovery of excess payment made on account of grant of higher rate of increment i.e 4%.
4. To call for explanation from the Senior Administrative Officer and the then Director-in-Charge, Dr SC Laroija.
5. To report the matter to the Ministry of Human Resource Development.

A detailed UO note No.11 dated 16.03.2010 was sent to Chairman, BoGs for placing Mr.Sunil D. Jassal, Assistant Professor, Mech Engg Department, under suspension on account of :

- (i) that Mr.Jassal along with Sh.P.S. Rao, Assistant Professor Mech Engg Dept of this institute submitted a research paper for presentation at the National Conference held at Kolkata, which was copied from the paper of one Mr.Leonhard E. Bernold, Associate Professor, Dept of Civil Construction and Environmental Engg, NC State Raleigh, USA. Details are indicated in the UO attached.
- (ii) Not only the above, Mr.Jassal threatened the Director of the institute, and misbehaved with the Director in presence of faculty.

However, he sought apology from the Director later on and has presently applied for Extra Ordinary Leave for five years stating I am feeling suffocated due to the developments taken place in the last 2-3 months. He further stated that he be permitted to work anywhere else outside the institute for a period of five years w.e.f. 25.07.2010.

B.16.4.10(4) TO CONSIDER THE REQUEST OF DR. SC LAROIYA,  
PROFESSOR & HEAD, MECHANICAL ENGINEERING,  
FOR VOLUNTARY RETIREMENT

Dr. SC Laroiya, Professor & Head, Mechanical Engineering Department of this institute, vide his letter dated 25.03.2010 (copy enclosed), has sought voluntary retirement wef 1st April, 2010.

In terms of Rule 48A of CCS (Pension) Rules, an employee can seek voluntary retirement on completion of 20 years of qualifying service, by giving notice of not less than three months in writing to the Appointing Authority.

As laid down in rule 48-A sub rule(1) *ibid*, the notice of voluntary retirement shall require acceptance by the Appointing Authority:

"Provided that where the Appointing Authority does not refuse to grant the permission for retirement before the expiry of the period specified in the said notice, the retirement shall become effective from the date of expiry of the said period."

Further, a Government servant may make a request in writing under above referred sub rule(1) to the Appointing Authority to accept notice of less than three months for voluntary retirement giving reasons thereof.

The Appointing Authority may consider such request for the curtailment of the period of notice of three months on merits if satisfied that the curtailment of the period of notice will not cause any administrative inconvenience on the condition that the Government servant shall not apply for commutation of a part of his pension before the expiry of the period of notice of three months.

Dr. SC Laroiya joined this institute on 12.01.1972 and is a permanent employee. He has completed 38 years of service. He has not given three months notice as required under the rules. However, he has not stated reasons for not giving the required notice. He has simply requested to waive off the notice period of 3 months for this purpose. However, it can be said in his favour that in the last six years of service rendered by him he not availed himself of any Earned Leave, in the light of this, his prayer for waiving off the customary notice period of three months may be considered favourably.

Chairman Board of Governors has desired that the case be put up in Board of Governors meeting on 13.04.2010.

Subject : To place under suspension Sh.Sunil D. Jassal, Assistant Professor, Mechanical Engineering Department, of this institute.

It was brought to the notice of the undersigned that Sh.Sunil D. Jassal along with Sh.P.S. Rao, Assistant Professor, Mechanical Engineering Department, of this institute submitted a research paper titled 'Emerging Need of Quality Teaching Techniques for Excellence In Engineering Education' for presentation in the National Conference on Recent Trends in Engineering & Education (RTEE-2010) held at NITTTR Kolkata, January 28-29, 2010, which was copied from the paper 'Applying Total Quality-Management Principles to Improving Engineering Education' authored by Leonhard E. Bernold, Associate Professor, Department of Civil Construction and Environmental Engineering, NC State University, Raleigh, NC USA and published in January 2008 issue of ASCE Journal of Professional Issues in Engineering Education and Practice.

In order to unearth the truth, the undersigned constituted a Committee consisting of three senior Faculty Members of the institute. The committee submitted its report establishing that the paper was found to be copied from the above said paper. Further, the committee also reported that the authors have misrepresented the facts and figures by interchanging / substituting the names of American Organization with the Indian counterparts. Report of the committee is attached as **Annexure I**.

Mr.Jassal became offended from the above step initiated by the institute and started behaving insubordinately and indecent manners. Not only this, he started threatening the undersigned of dire consequences.

Sometime back, in a function / tea party of the faculty Mr.Jassal started shouting and abusing the undersigned and even used threatening language in the presence of all faculty members.


On 03.03.2010 Mr.Sunil D. Jassal came to the office of the undersigned to meet the Director. But the PA of the Director asked Mr.Jassal to wait as the Director was busy. But Mr.Jassal did not listen to him and entered in the

office of the Director forcibly. A statement of P.A. Sh.C. Venugopalan is attached as **Annexure II**.

On 15.03.2010, Mr.Jassal again came to the office of the undersigned and delivered one confidential letter to the PA of the undersigned with a statement that the letter in the envelope is an apology written by him. As the undersigned was busy in meeting in the morning, the PA handed over the letter to the undersigned in the late afternoon yesterday and the undersigned asked the PA, Sh.Gurdev Singh to open the letter. After opening he handed over the letter to me. I was stunned to read the contents of the letter which is simply a threatening letter. The letter bears no signature, though, a copy of the same is attached as **Annexure-III**. The undersigned handed over this letter to the designated committee of the institute comprising three senior Professors to give their views. These Professors recommended that Mr.Jassal may be placed under suspension immediately and he should be debarred from entering into the institute premises. The recommendations of the Senor Professors dated 16.03.2010 is attached as **Annexure IV**.

In view of the above, you would appreciate that the acts of Mr.Jassal have been vitiating the atmosphere of the institute. Moreover, he has extended an open threat to the undersigned and his presence in the institute may lead to some untoward incident. In the light of above, it is proposed that Mr. Sunil D. Jassal, Associate Professor, may be placed under suspension with immediate effect under rule 10 (1) of CCS / (CCA) Rules, 1965 of Disciplinary Proceedings. He may also be debarred from entering the institute premises. The charge sheet will be prepared and shall be got approved from the Chairman, BOGs, in due course of time.

1. Sh. P.S. Rao and Sh. Sunil Jassal were asked vide letter No. NITTTR/928-929 dated 09/02/2010 to appear before the committee on 10/02/2010 at 11.30 a.m. in the office of Professor and Head, Mechanical Engineering Department.
2. Sh. Sunil Jassal appeared before the committee on the said date and time whereas Sh. P.S. Rao was on medical leave from 10/02/2010 to 11/02/2010.

On his request, Sh. S.D. Jassal was given a copy of the research paper titled "Emerging Need of Quality Teaching Techniques for Excellence in Engineering Education", which was included in the conference proceedings of the National Conference on Recent Trends in Engineering & Education (RTEE-2010) held at NITTTR, Kolkatta, January 28-29, 2010. After examining the copy of the said paper, Sh. S.D. Jassal replied in writing that the said paper was neither authored nor submitted by him in any conference or journal.

The Committee decided to fix the next date of meeting after Sh. P.S. Rao joins his duties after availing the medical leave.

3. Sh. P.S. Rao joined his duty on 15/02/2010 after recovering from illness and he appeared before the committee on 16/02/2010 at 3.30 p.m. in the office of Professor and Head, Mechanical Engineering Department.

Rao was given a copy of the research paper titled "Emerging Need of Quality Teaching Techniques for Excellence in Engineering Education", which was included in the conference proceedings of the National Conference on Recent Trends in Engineering & Education (RTEE-2010) held at NITTTR, Kolkata on January 28-29, 2010.

Sh. P.S. Rao was asked whether he had authored the said paper. Sh. P.S. Rao informed the committee members that he would study the paper and give his reply by Friday the 19<sup>th</sup> February, 2010.

The committee decided to hold the next meeting on 19<sup>th</sup> February, 2010, for getting the reply of Sh. P.S. Rao.

4. Sh. P.S. Rao was on medical leave for one day on 19-02-2010 and hence could not appear before the committee on that day. Sh Rao presented himself before the committee on 22<sup>nd</sup> February, 2010.

Sh. P.S. Rao submitted his written reply in which he stated that the abstract, introduction, contents of the paper, conclusion, references etc. of that paper which was provided to him by the committee having the signatures of the committee members on it were quite different from the original paper which Sh. P S Rao and Sh. Sunil Jassal had sent to the NITTTR, Kolkata.

Sh. P.S. Rao was asked to submit that paper which according to him was submitted by himself and Sh. Sunil Jassal to NITTTR, Kolkata. Sh. P S Rao submitted the paper duly signed by both Sh. P S Rao and Sh. Sunil Jassal, which was examined by the committee members and found to be totally different in content vis-à-vis the paper published in the conference RTEE-2010. It was decided to request the Director to contact NITTTR, Kolkata to supply the research papers and other documents submitted by Sh. P S Rao and Sh. Sunil Jassal for presentation in the conference RTEE-2010. The Sr. ADO of our institute was also requested on 19-02-2010 to supply the copies of latest self-appraisal reports submitted by Sh. P S Rao and Sh. Sunil Jassal to the office.

Director, NITTTR, Kolkata had sent the copies of two research papers titled "Emerging Need of Quality Teaching Techniques for Excellence in Engineering Education" and "Developing Entrepreneurial Abilities Through Training – A Recent Trend in Engineering & Education", submitted by Sh. P S Rao and Sh. Sunil Jassal to Dr Subrata Chattopadhyay, Conference Steering Committee, RTEE-2010 along with the copy of the covering letter sent by Sh. P S Rao through his e-mail account "sudhakar rao patange <[psrao\\_mech@yahoo.co.in](mailto:psrao_mech@yahoo.co.in)>" dated December 16, 2009.
6. The copy of the research paper titled "Emerging Need of Quality Teaching Techniques for Excellence in Engineering Education" supplied by Director, NITTTR, Kolkata is the same as published in the conference proceedings CD. The said paper was found to be copied from the paper "Applying Total-Quality-Management Principles to Improving Engineering Education" authored by Leonhard E. Bernold, Associate Professor, Dept. of Civil Construction and Environmental Engineering, N.C. State Univ., Raleigh, NC, USA and published in January 2008 issue of ASCE Journal of Professional Issues in Engineering Education and Practice (copy attached).
7. The copy of the e-mail clearly states that the above mentioned two papers were co-authored by Sh. P. Sudhakar Rao and Sh. Sunil Jassal. The alternate e-mail IDs of Sh P S Rao ([psrao\\_mech@yahoo.co.in](mailto:psrao_mech@yahoo.co.in) and [psrao@nitttrchd.ac.in](mailto:psrao@nitttrchd.ac.in)) as well as e-mail ID of Sh Sunil Jassal ([jassalsd@yahoo.com](mailto:jassalsd@yahoo.com)) were mentioned in the said e-mail communiqué.
8. The copies of latest self-appraisal reports submitted by Sh. P S Rao and Sh. Sunil Jassal indicate that both had authored a number of papers jointly during the recent past.
9. **Findings:** In light of the above facts, it may be concluded that:
  - a. Sh. P S Rao and Sh Sunil Jassal jointly submitted the research paper titled "Emerging Need of Quality Teaching Techniques for Excellence in Engineering Education" for presentation in the National Conference on Recent Trends in






- b. That the said paper was found to be copied from the paper "Applying Total-Quality-Management Principles to Improving Engineering Education" authored by Leonhard E. State Univ., Raleigh, NC, USA and published in January 2008 issue of ASCE Journal of Professional Issues in Engineering Education and Practice.
- c. Moreover, while comparing the original paper with the paper submitted by Sh. P S Rao and Sh Sunil Jassal, it is noted that authors have misrepresented the facts and figures by interchanging/substituting the names of American organizations with their Indian counterparts.


10. **Suggestive Remedial Measures:** To avoid the occurrence of such cases in the future, the committee suggests the following remedial measures:

- a. The institute needs to frame a policy on plagiarism on the lines of IITs and other central institutes.
- b. A permanent standing committee on plagiarism may be constituted which may look into such cases as and when reported.
- c. Whenever a faculty member of the institute sends a research paper for publication/presentation, he/she should submit a declaration form on "Copyright and Authorship" as well as signed copy of the research paper.



The letter (copy enclosed) handed over to Shri Gurdev Singh, PA to Director of institute by Mr. Sunil Jassal, Assistant Professor, Mechanical Engineering Department of institute on 15.3.2010 in presence of Mr. RB Tiwari, Assistant in Accounts Section was discussed in detail and following recommendations were arrived at:

- (i) The content of the letter is shocking , surprising and derogatory. The committee condemn such a deed.
- (ii) Since there is threat to Director's life, security arrangement shall be augmented and strengthened. It is suggested that Police security may also be availed in this regard.
- (iii) The content of above cited letter are full of malafidies. The letter embodies threat to kill/injure the Director of the institute, which clearly shows that Mr. Jassal is desperate to take any extreme steps against the Director including severe physical harm to him.

In the light of above and looking into the seriousness of the matter, the Committee recommends suspension of Mr. Sunil Jassal with immediate effect and also recommends that Mr. Sunil Jassal should be debarred from entering in the institute premise with immediate effect till the final decision of the case.
