The Board of Governors in its 13th meeting held on 13.02.2009 vide item No.B.13.4.1 (Against Finance Committee item No.F.13.3) approved change of designation of Senior P.A., Stenographer Grade-I and Grade-II to Personal Assistant consequent upon the merger of the pay scales of the posts referred to above, viz Rs.6500-10500, Rs.5500-9000 and Rs.5000-8000 to Pay Band 2 i.e. Rs.9300-34800 with Grade pay of Rs.4200/-.

The Government of India M.F. O.M. No.F.No.1/1/2008-IC, dated 13.11.2009 decided that the posts which were in the pre-revised scale of Rs.6500-10500 as on 01.01.2006 and which were granted normal

replacement pay structure of grade pay of Rs.4200 in the pay band PB-2, be granted grade pay of Rs.4600 in the pay band PB-2 corresponding to the pre-revised scale of Rs.7450-11500 w.e.f. 01.01.2006, which has been adopted at this institute.

Now that a distinction is made between two categories vis-à-vis grade pay of Rs.4200 and Rs.4600, it is, but in the fitness of the things that separate designations are conferred in two categories. Accordingly, Personal Assistants with grade pay of Rs.4600/- have been restored the designation of Senior Personal Assistant (provisionally).

ITEM NO.B.17.3.2 TO ADOPT THE GUIDELINES OF AICTE GAZETTE NOTIFICATION DATED 05.03.2010

The institute adopted the scheme of revision of pay scales of teachers and equivalent cadres of NITTTR Chandigarh duly approved by the Board of Governors in its 15th meeting held on 11.10.2009 vide item No.B.15.3.1 as delineated by the MHRD, Government of India vide its letter dated 18 August 2009.

As per UGC Regulations on minimum qualifications for appointment of teachers and other academic staff in Universities and Colleges and measures for the maintenance of standards in higher education 2009 vide its Gazette Notification (to be published in the Gazette of India Part III Sector 4) vide notification dated 20.03.2009 states that:

'these regulations are for revision of pay scales, minimum qualifications for appointment, and other service conditions of University and College Teachers, Librarian and Directors of Physical Education as a measure for the maintenance of standards in higher education.'

It further states at Sr.No.1.1.1. in the above said notification dated 20.03.2009,

'...... for engineering, pharmacy and management, the norms / regulations of AICTE shall apply.'

It is to bring to the kind notice of the Board that AICTE vide its Gazette Notification dated 05.03.2010, notified pay scales, service conditions and qualifications for the teachers and other academic staff in technical institutions (Degree) regulations, 2010.

It is mentioned that the pay of teachers, designations and other service conditions as mentioned in MHRD letter no.f.No.23-1/2008-TS.II dated 18.08.2009 were implemented at NITTTR Chandigarh, It is proposed that qualifications, career advancement scheme etc. of AICTE Gazette Notification dated 05.03.2010 be adopted for teachers of this institute.

Based on the AICTE/UGC recommendations, qualifications for various faculty positions have been amended. The same will be placed before BOG at the time of meeting for approval.

THE BOARD OF GOVERNORS MAY KINDLY CONSIDER AND APPROVE

ITEM NO.B.17.3.3 TO CONSIDER REDISTRIBUTION OF EXISTING VACANT POSTS OF ASSISTANT PROFESSORS AND TO ADVERTISE THE VACANT POSITIONS.

ITEM NO.B.17.3.5 TO DELEGATE POWERS / RESPONSIBILITIES OF SENIOR ADMINISTRATIVE OFFICER TO FACULTY IN CHARGE ADMINISTRATION.

The post of Senior Administrative Officer fell vacant in March 2010 when the incumbent, Shri KL Singla, proceeded on deputation for one year to NIPER, Mohali. As a temporary measure, the Accounts Officer, Mr. P.P. Kaushik, took over the charge from Mr. Singla in addition to his own duties.

Now, Dr RK Wats, Associate Professor, Media Centre has been appointed as the Faculty-in-charge Administration (in addition to his own duties) to carry out the responsibilities of the Senior Administrative Officer vide office order no.Estt./53 dated 22nd June 2010. However, as per institute rules,

such a post i.e. 'Faculty-in-charge Administration' does not exist. This is a new designation and therefore, needs approval of the Board. As per institute Rules (Delegation of Powers-2003), administrative/financial powers, to the prescribed extent, are vested in the Senior Administrative Officer. It is, therefore, necessary that such powers are delegated to the Faculty-in-Charge Administration to meet the requirement of rules.

As provided in rule 15(f) of the Institute Rules, the Director may delegate any of his powers to any officer(s) in service of the Society with the approval of the Board.

THE BOARD MAY KINDLY CONSIDER AND APPROVE DELEGATION OF ADMINISTRATIVE AND FINANCIAL POWERS (PRESENTLY VESTED IN THE SENIOR ADMINISTRATIVE OFFICER) TO THE FACULTY IN-CHARGE ADMINISTRATION TILL THE POST OF SENIOR ADMINISTRATIVE OFFICER IS FILLED UP.

ITEM NO.B.17.3.6 TO CONSIDER PROVISION OF HEADSHIP BY ROTATION

While rotation headship is a very common and regular phenomenon in most of the educational institutions of the country. An item on the above subject was discussed during 3rd meeting of the Director of four NITTTRs held at Bhopal on 18th March 2010. It was apprised to the members that NITTTR Bhopal has introduced the rotational Headship from amongst the Professors and Readers in order to facilitate the situation where all faculty members of the Departments and Centers will have an opportunity to lead the Department / Centre. It is proposed that the same may be introduced at NITTTR Chandigarh up to the level of Associate Professors.

ITEM NO.B.17.3.8 TO CONSIDER CHANGE OF QUALIFICATIONS AND MODE OF APPOINTMENT TO THE POST OF JUNIOR ELECTRONICS ENGINEER

Staff service regulation was last amended consequent upon adoption of Revised Pay Rules 2008 in the Finance Committee meeting vide item F.No.13.3 and subsequently approved by the Board of Governors in its 13th meeting held on 13.02.2009 vide item No.B.13.4.1, wherein the post of Junior Electronics Engineer was placed in PB-2 Rs.9300-34800 with grade pay of Rs.4200. The mode of appointment was approved as (i) 67% by promotion on seniority cum fitness basis from amongst Technicians having at least 3 years diploma in Electronics and (ii) 33% by open

selection. Prior to this, the post was being filled up from amongst the Senior Technical Assistants (STA), whose pay scale was Rs.5500-9000.

In the 6th pay commission order, the pay band and grade pay were declared common for the post of Junior Electronics Engineer (old pay scale of Rs.6500-10500) and Senior Technical Assistant (Pay scale of Rs.5500-9000) in PB-2 9300-34800 with grade pay of Rs.4200.

Thereafter, the GOI enhanced the grade pay of Junior Electronics Engineer to Rs.4600 vide M.F. O.M. No.1/1/2008-IC dated 13.11.2009 which has been adopted at the institute.

Therefore, there is a need to restore the mode of appointment of Junior Electronics Engineer for filling promotion posts from amongst the Senior Technical Assistants in place of Technicians. A committee constituted at the institute has recommended change in qualifications and mode of appointment, the report of which is attached as **Annexure - X** at page No. 147.

 PERSONS WITH DISABILITY PROJECT - COORDINATOR DR JS SAINI

Centre for Physically Challenged, NITTTR, Chandigarh in collaboration with Northern Chapter of Confederation of Indian Industry (CII), organized an **Ability Fair 2010** for differently abled persons in a phased manner. Four such job fairs were organized on 24 April, 28 April, 5 May and 25 May, 2010. Two well renowned companies namely Tech Mohindra Ltd. and IBM Ltd. visited the institute for recruitment of differently abled persons. The two companies recruited 42 persons for placement in their call centres.

 TECHNOLOGY PARK OF EMERGING TECHNOLOGY FOR RURAL DEVELOPMENT – IIT DELHI SPONSORED PROJECT

IIT Delhi has given Rs.6.30 lakh as first instalment out of total grant of Rs.15.75 lakh. The project terms is two and half years commencing from June 2010. Out of Rs.6.30 lakh, a Bio Gas Plant has been installed in the Institute Campus. The main purpose of the installation of Bio Gas plant is to utilize kitchen waste (Vegetable Waste) as cooking fuel in the institute canteen. A 4 cubic metre Deen Bandhu Model of Bio Gas Plant was constructed with the help of KVIC Chandigarh and was inaugurated on the eve of World Environment Day on 4th June, 2010. IIT Delhi project is a part of a bigger project on "Bio Energy: Technology Business Solution for UK and India.

3. MeLT VAN – A PRIZED ACQUISITION GIFTED BY IIT, ROORKEE

The Mobile e-Learning Terminal (MeLT) project of IIT Roorkee sponsored by MHRD, Govt. of India under "National Mission on Education using ICT" is an innovative approach to reach the remote region to offer education through blended learning. Prof. H.K. Verma, Deputy Director of IIT Roorkee and PI of the project after interacting with NITTTR Chandigarh, more specifically with the ETV Centre of the institute, realized the potential of the centre and handed over a MeLT Van to ETV Centre to carry out

activities to meet the national objectives. The ETV Centre conducted three programmes on April 30, 2010, May 01, May 06 and 07, 2010 at various place at Chandigarh and Derabassi which was highly appreciated by the organisations. Seeing the institute activities, Prof. HK Verma, in principle, agreed to hand over, permanently, the MeLT Van along with equipments (worth 20 Lakhs) to ETV Centre. For each programme, however, the institute (NITTTR) has to bear the expenditure on Driver and fuel.

4. INVITATION FROM MS. MICHELLE GRIMLEY, BUSINESS DEVELOPMENT EXECUTIVE, SCOTLAND COLLEGES INTERNATIONAL

An invitation has been received from Scotland vide email dated 20.07.2010, proposing the funding of visit of 3 staff members of this institute to Scotland for a period of 3-4 days. It is mentioned that funding is from Education UK which is part of the British Council in Scotland. It has a time limit of July, 2010.

 HOSTEL CONSTRUCTED BY CPWD AWARDED FIRST PRIZE BY CPWD

Review meetings were held in connection with celebration of 156th Year of Annual Day on 12.07.2010 organised by Centre Public Works Division (CPWD) at Vigyan Bhawan New Delhi. During the inaugural function, CPWD Chandigarh was awarded Certificate of Merit for Best Projects. Construction of New Hostel Block (Boys & Girls) and 9 Numbers Lecture Hall, has been awarded the 1st Grading, in the category of Residential Building in the function.

Out of the sanctioned amount of Rs.1213.78 lacs for the project, it is expected that there will be a saving of about Rs.111.00 lacs. The Building and Construction Committee of the institute proposes to undertake the following additional developmental work from this saving, through CPWD:

- 1. Development of Language and Communication Skill Lab
- Construction of an open-air theatre
- 3. Allweather connectivity to hostel

- 4. Development of Athletic Track
- 5. Wire-mesh shutter towards corridor side in the hostel rooms
- 6. Facelift and external renovation works of the institute
