The institution must adhere to the following terms and conditions:

1. The institution shall run the courses in accordance with the provisions of the UGC Guidelines for Providing Skill-based Education under National Skills Qualifications Framework (NSQF).
2. The institution shall meet the requirements of infrastructure and laboratory facilities for running the skill-based courses.
3. If the institution is recommended for running skill-based courses in the fields like medicine, law etc., it shall meet the parameters specified by the concerned regulatory bodies / professional councils.
4. The courses will be offered on regular mode only. The Institution shall not run the courses on online / distance education mode and through franchise arrangements.

ITEM NO. A.24.15: To Consider and Approve the adoption of Admission Criteria of respective affiliating university / GoI Norms

As per our ME Prospectus, NITTTR Chandigarh is considering Aggregate of 60% Marks in qualifying examinations for considering the candidate eligible for admission. However, no relaxation is made of SC/ST candidates. It is proposed to drop this aggregate marks our criteria of

admission and suggested to follow the admission criteria of affiliating University.

ITEM NO A 24.17: To Consider Waiving-off of Application/Registration/Admission/ Tuition fee to be paid by Institute Faculty and Staff Registered for ME/PhD Programmes at this Institute

On the subject stated above the institute had taken up an item in the Finance Committee meeting scheduled on 24.10.2008, for waiving-off Tuition Fee for the faculty and staff registered for ME/Ph.D programmes being run by this Institute. The finance committee recommended that the Tuition Fee payable by the Institute Faculty/Staff registered for ME/Ph.D at the Institute itself may be waived off with prospective effect. However, such institute employees will have to pay the fee payable to the Affiliating University with which the Institute is presently affiliated to. Members of the Academic Council may consider recommending to Finance Committee to replace **tuition fee to any type of fee** payable to NITTTR, Chandigarh by the faculty and staff of the Institute who are registered for Ph.D programmes.
