The honorarium which is being paid by NITTTR, Chandigarh to external experts in connection with the above-mentioned activities is quite low and as a result the institute is unable to attract experts from premier technical institutions like IITs, NITs, etc. With a view to ensuring quality and to get good feedback from experts of these premier technical institutions, the Academic Council recommended that the norms for payment of honorarium for thesis evaluation and examination be revised as under.

ITEM NO. A.21.6:

TO CONSIDER THE PROPOSAL FOR CONDUCT AND FUNDING OF STUDENTS RELATED PROFESSIONAL ACTIVITIES

NITTTR Chandigarh charges at present ₹ 1500/- and ₹ 575/- per annum from ME/MTech students on account of students welfare fund and student activity fee and approximately ₹ 2,50,000 get collected annually. This amount is likely to go up to approximately ₹ 4,50,000/- after implementation of revised norms. The Academic Council recommends that following activities be conducted by the engineering departments from this fund.

I. Organisation of National Tech Fest in the Institute. One of the engineering departments by rotation may coordinate this activity every year. Both ME/MTech & PhD students of our Institute and other Institutes will participate in this activity.

II. Setting up of student chapter of professional bodies by all the five engineering departments. These chapters may organize activities like project competition, collaborative seminars etc. The Dept. will be paid ₹ 20,000/- per annum from the above fund. Both ME/MTech and PhD students of NITTTR, Chandigarh will be beneficiary of this activity. A committee of Dean, A&IA and Dean, R&D along with two more faculty members to be nominated by the Director would evolve mechanism for operationalising the above activities.

ITEM NO. A.21.7: REVISION OF RENT CHARGES FOR INSTITUTE HOSTELS

Recommendation of the committee constituted by Director for revision of rent charges in the institute hostel were deliberated during the meeting. This will facilitate the institute to engage manpower like sweeper, mali, security and attendant in the hostel on self-financing mode for which there are no sufficient sanctioned posts.

ITEM NO. A.21.8: CREATION OF A FUND FOR SUPPORTING PHD SCHOLARS

A need is felt in the institute to have regular PhD Scholars. This dedicated team of PhD Scholars can be provided scholarship from institute funds for a maximum period of two years per scholar subject to qualifying in performance evaluation in every semester. These scholars, in addition to pursuing their PhD work under the faculty of the Institute, will also assist their respective departments in conduct of their programmes and projects. It is recommended to have eight PhD Scholars per year under this scheme (one each from five engineering departments and three from inter-disciplinary areas of Management/Entrepreneurship, Education, and ETV, one each for the present moment). This may be increased in future depending upon availability of the budget. For the subsequent year, the guide and the student will write project and submit to any funding agency for financial support.

Every PhD Scholar under the scheme will be given a monthly scholarship of ₹ 10,000/- and contingency expenses of upto the ₹ 5,000 per annum (Total expenses per PhD Scholar ₹ 1.25 Lakhs per annum). Following is the annual expenditure on account of these eight PhD Scholar to be admitted every year.

With a view to meet the above expenditure, it is proposed that a corpus be created. This corpus can be funded by allocating 30% of funds of the overhead expenditure deducted from each consultancy projects/proceeds of the institute every year. Each beneficiary shall execute a bond to stay

with the institute for three years, else the total amount disbursed will be recovered from him/her. The head already created under TEQIP-II funds shall also be used for the said purpose. The criteria shall be decided by the Committee consisting of all Deans and two experts nominated by the Director

ESTABLISHING A BUSINESS INCUBATION CENTRE AT NITTTR, ITEM NO. A.21.9: **CHANDIGARH**

Entrepreneurship Development and Industrial Coordination Department was established at the institute in 1982. One of the major objectives of establishing this department was to promote entrepreneurship through technical institutions. Over the past 36 years the Department has done considerable work in promoting entrepreneurship in technical institutions Keeping in view the across the northern region of the country. government's thrust on entrepreneurship and start-ups, the institute proposes to establish a Business Incubation Centre in collaboration with one of the leading Chamber of Commerce & Industry at Chandigarh as an extended activity of EDIC Department of the institute. The proposed Business Incubation Centre will have an annual intake of 5 incubatee. The peak number of incubatees is proposed to be restricted to 10. The maximum period of stay of an incubatee would be 2 years. A dedicated team comprising an Incubation Manager, a Field Officer, a Secretarial Support and a Category 'D' Support is proposed to be created at the institute for operationalising the Incubator. The proposed incubator shall have a separate Advisory Body, a Selecting Jury and a Pool of Mentors. The recurring overheads including the salary of the dedicated team are proposed to be borne by the Partnering Chamber. NITTTR's share of recurring expenses would be met from the regular grant received from the MHRD, GOI. The Ministry has already directed the institute to initiate activities pertaining to start-ups wide its email dated 23 October 2017 (Copy enclosed). A brief proposal highlighting the need for Incubation Centre, Objectives, Operational Mechanism of the Centre, Organisational Chart, Activity Spectrum, Mobilisation of Funds and Projected outcome is enclosed as Annexure-I.

The Academic Council recommended the proposal for approval from the BOG.

LAUNCHING OF NEW COURSES BY ETV DEPARTMENT ITEM NO. A.21.10:

The ETV department proposes to launch certificate courses of 3 months, 6 months and also advance diploma for one year in different specialization of video production under self-financing mode. The eligibility for these courses



will be 10+2/Graduation in any discipline. Fee for these courses are ₹8,000, ₹ 12,000 and Rs.20,000 for 3 months, 6 months and 1 year courses respectively. Details of these proposed courses are attached as Annexure-II. This is to optimally use the available facilities.

Members of the Academic Council recommended the proposal for approval from the Board of Governors.

ITEM NO. A.21.11: TO REPORT ON THE ACHIEVEMENTS OF THE INSTITUTE FOR THE PERIOD FROM APRIL 2017 TO 8 MARCH 2018.

The achievements of the institute with respect to admission in long-term programmes, short-term programmes offered through contact mode and ICT mode, student training, workshop and seminars. curriculum design and development, instructional material development, research & development. extension and consultancy. Golden Jubilee activities and other significant achievements for the period from April 2017 to 8 March 2018 were presented by the Member Secretary. The institute was advised to set target for individual faculty members and for the institute as a whole for the upcoming three years as recommended in one of the Review Committee Reports.

ITEM NO. A.21.12: TO APPROVE THE OPERATIONAL PLAN OF THE INSTITUTE FOR THE YEAR 2018-19

The Operational Plan of the institute for the year 2018-19 was deliberated and recommended for approval by the BOG. O.Plan for 2018-19 is enclosed as Annexure-III. The Members praised the three-category approach of conducting STCs. The members also appreciated the concept of creating and utilizing the Training Hubs in Resourceful Institutes of Higher Learning. The target set for each faculty is 200 participants in contact mode and 350 participants in ICT mode i.e. total 550 participants. However, HODs/Deans and faculty involved in ME/MTech Classes and having sponsored projects of more than 10 lakhs have been given a relaxation of 50 participants in each mode.

It was decided to create quarterly profile of each individual faculty member stating the target set and achievement. The faculty annual performance report shall reflect the grading based on the performance against the set target. Authority is advised to prepare the grading pattern target-wise and circulate to each individual faculty member by 1st week of April every year.

Dr HK Sardana suggested to explore the possibilities to use the facilities of Chandigarh Region Innovation and Knowledge Cluster (CRIKC) collaborative research. Prof MM Malhotra advised the institute to take up action research on the burning issues of technical education system and submit duly evaluated report to the Ministry.
