TO CONSIDER AND APPROVE THE ENHANCEMENT OF ROAD MILEAGE BY OWN CAR BETWEEN PLACES CONNECTED BY RAIL.

Road mileage at the rate of Rs. 6/- per Km is being paid to experts invited for expert lectures/talks in various institute etc programs when they travel by own car. The same rate is also applicable to institute employee when they use own car for official purpose. Due to increase in price of petrol/Diesel, road mileage of Rs. 6/- per km is not sufficient to meet the propulsion charges born by the expert for using own car for the journey. Meeting of the HODs recommended the payment of road mileage @ Rs. 10/- per KM, when the experts or institute faculty/staff perform the journey by own car in public interest.

Expert are invited from industries, R&D organizations and academia to deliver expert lecture/talks in the various activities of the institute. Chandigarh lacks Air India connectivity from many places including important cities of the country. The available connectivity in many cases takes more than 10 hours which is not suitable to experts. Therefore, Hon'ble members may kindly allow travel by other airlines in cases where no direct flight connections by Air India are available.

ITEM No. 39.3.5 ENHANCEMENT OF APPLICATION FEE FOR TEACHING AND NON -TEACHING POSTS

The institute charge Rs. 100/- for teaching post and Rs. 60/- for non-teaching post as application fee. SC/ST/PWD/Women candidates are exempted from the application fee. The rates was fixed approximately 15 years back. Therefore, it is proposed to enhance the application fee to Rs. 1000/- for teaching post and Rs. 750/- for non-teaching post. There will be no fee for SC/ST/PWD/Women candidates.
