

ITEM NO. F.46.3.2

TO CONSIDER FEE TO BE CHARGED FOR VARIOUS PAID STC PROGRAMMES.

The institute has a norm to charge Rs. 10,000/- per week/per participant from TEQIP funded institute. For Non-AICTE approved colleges and industry participants, the fee is Rs.5,000/-per week per participant. In the changing scenario, the diversified learning are getting encouraged and many on-line programmes are launched. The fee to be charged will vary from programme to programme (STC to STC). Therefore, it is proposed to allow the department to propose the fee to be charged for on STC to STC basis and on approval of the Director, same can be implemented.

The participants from UGC affiliated colleges/institutes/universities in Short Term Courses, refresher courses and training programmes etc. conducted by the Institute shall be allowed to pay same fee at par with Non-TEQIP AICTE affiliated colleges/institutes/universities or as decided by the Department and approved by the Director.

TO CONSIDER AND APPROVE TA CLAIMS AFTER DUE DATE OF SUBMISSION

Four faculty members of this institute have requested to reimburse their TA claims for the official journey performed by them and submitted their claims to Accounts Section after due date. ### Rule Position:

"As per Rule 290 of GFR 2017 the time limit for submission of claims for Travelling Allowance has been changed from one year to 60 days succeeding the date of completion of journey in terms of Government of India letter No. 19030/1/2017-E.IV dated 13-03-2018 Annexure- VIII (Pg No. 25-26)

The claim of Government servant to Travelling Allowance/Daily Allowance on Tour/ Transfer is forfeited or deemed to have been relinquished if the claim is not preferred within 60 days succeeding the completion of journey".

The above rule does not permit for reimbursement of late travel claims of the said employees. Keeping in view the genuine reasons cited by the above faculty members in their request letters, Finance Committee may kindly consider their request and allow them reimbursement of their travel claims, as a special case. It is to add here that they have not taken any TA advance to perform their official journeys.
