In compliance forwarded letter No.F.No.15-1/2017-TC(Vol-II) dated 29th December, 2017, NITTTR Chandigarh has extended the benefit of 7th CPC to the Institute officers/officials wef 1st January,2016 after the approval Hon'ble Board of Governors vide item No.40.4.7.

Now Department of Expenditure, Ministry of Finance, Govt. of India vide No.4-21/2017-IC/E.IIIA dated 28th November, 2019 has issued the clarifications for the entitlement of employees for drawal of annual increment either on 1st January, or 1st July depending on the date of appointment, promotion or grant of financial upgradation **Annexure - III (P. No.7-9)** as under:-

Since there is material change, it has been approved that the employees who have been regularly promoted or granted financial up-gradation on or after 01.01.2016 and desire to exercise/re-exercise option for pay fixation under FR 22(I)(a)(1) shall be given an opportunity to exercise or re-exercise of the option there under. Such an option shall be exercised within one month.

In view of above clarifications, Institute officers/officials may allow to exercise their option under Rule 10 of CCS (Revised Pay) Rules 2016.
