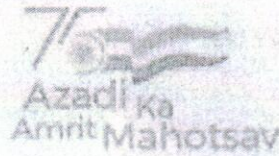

#### ITEM NO. F. 53.3.1 TO CONSIDER STATUS REPORT ON PROGRESS OF CAPITAL AND REVENUE EXPENDITURE UPTO 7.6.2022

The institute should start generating revenue from these centres and must release the matching amount in next 8 to 10 years. No fund of the grant received for the purpose from the Ministry will be used for manpower hiring against these Centres of Excellence.


